HB21-1250 be amended as follows:

1 Amend reengrossed bill, page 3, strike lines 12 through 20 and substitute:

2           "(2.5) "EXONERATED" MEANS DISMISSAL OF CHARGES BY THE  
3 COURT OR APPROPRIATE PROSECUTOR OR A NOT GUILTY VERDICT IN A  
4 CRIMINAL PROSECUTION, A FINDING OF NO LIABILITY IN A CIVIL ACTION, A  
5 FINDING OF NO CULPABILITY OR NO LIABILITY OR SIMILAR DETERMINATION  
6 IN AN ADMINISTRATIVE PROCEEDING, OR A FINDING OF NOT SUSTAINED IN  
7 AN INTERNAL INVESTIGATION; EXCEPT THAT A FINDING OF NO CULPABILITY  
8 OR NO LIABILITY IN AN ADMINISTRATIVE PROCEEDING OR A FINDING OF  
9 NOT SUSTAINED IN AN INTERNAL INVESTIGATION DOES NOT MEAN  
10 "EXONERATED" IF THE OFFICER IS FOUND GUILTY IN A SUBSEQUENT  
11 CRIMINAL PROSECUTION FOR THE SAME CONDUCT OR FOUND LIABLE FOR  
12 THE SAME CONDUCT IN A CIVIL ACTION."
