

HB21-1301 be amended as follows:

1 Amend printed bill, page 12, before line 26 insert:

2           **"SECTION 8. Appropriation.** (1) For the 2021-22 state fiscal  
3 year, \$104,780 is appropriated to the department of agriculture for use by  
4 agricultural services. This appropriation consists of \$52,390 from the  
5 industrial hemp registration program cash fund created in section 35-61-  
6 106 (1), C.R.S., and \$52,390 from the marijuana tax cash fund created in  
7 section 39-28.8-501 (1), C.R.S. To implement this act, the department  
8 may use this appropriation as follows:

9           (a) \$83,512, which consists of \$52,390 from the industrial hemp  
10 registration program cash fund and \$31,122 from the marijuana tax cash  
11 fund, for use by agricultural services for the plant industry division, which  
12 amount is based on an assumption that the department will require an  
13 additional 0.7 FTE; and

14           (b) \$21,268 from the marijuana tax cash fund for the purchase of  
15 legal services.

16           (2) For the 2021-22 state fiscal year, \$21,268 is appropriated to  
17 the department of law. This appropriation is from reappropriated funds  
18 received from the department of agriculture under subsection (1)(b) of  
19 this section and is based on an assumption that the department of law will  
20 require an additional 0.1 FTE. To implement this act, the department of  
21 law may use this appropriation to provide legal services for the  
22 department of agriculture.

23           (3) For the 2021-22 state fiscal year, \$279,194 is appropriated to  
24 the department of revenue. This appropriation is from the marijuana cash  
25 fund created in section 44-10-801 (1)(a), C.R.S. To implement this act,  
26 the department may use this appropriation as follows:

27           (a) \$247,292 for use by the specialized business group for  
28 marijuana enforcement, which amount is based on an assumption that the  
29 group will require an additional 1.9 FTE; and

30           (b) \$31,902 for the purchase of legal services.

31           (4) For the 2021-22 state fiscal year, \$31,902 is appropriated to  
32 the department of law. This appropriation is from reappropriated funds  
33 received from the department of revenue under subsection (3)(b) of this  
34 section and is based on an assumption that the department of law will  
35 require an additional 0.2 FTE. To implement this act, the department of  
36 law may use this appropriation to provide legal services for the  
37 department of revenue."
