

HB21-1317 be amended as follows:

1 Amend printed bill, page 20, after line 22 insert:

2           **"SECTION 10. Appropriation.** (1) For the 2021-22 state fiscal  
3 year, \$4,000,000 is appropriated to the department of higher education.  
4 This appropriation is from the marijuana tax cash fund created in section  
5 39-28.8-501 (1), C.R.S. To implement this act, the department may use  
6 this appropriation for regents of the university of Colorado for use by the  
7 school of public health. Any money appropriated in this section but not  
8 expended prior to July 1, 2022 is further appropriated to the department  
9 for the 2022-23 fiscal year for the same purpose.

10           (2) For the 2021-22 state fiscal year, \$460,227 is appropriated to  
11 the department of public health and environment for use by the center for  
12 health and environmental information This appropriation consists of  
13 \$173,250 from the general fund and \$286,977 from the medical marijuana  
14 program cash fund created in section 25-1.5-106 (16)(a), C.R.S. To  
15 implement this act, the center may use this appropriation as follows:

16           (a) \$102,417 from the medical marijuana program cash fund for  
17 personal services related to the medical marijuana registry, which amount  
18 is based on an assumption that the registry will require an additional 1.6  
19 FTE;

20           (b) \$184,560 from the medical marijuana program cash fund for  
21 operating expenses related to the medical marijuana registry;

22           (c) \$118,150 from the general fund for personal services related  
23 to health statistics and vital records, which amount is based on an  
24 assumption that the registry will require an additional 1.8 FTE; and

25           (d) \$55,100 from the general fund for operating expenses related  
26 to health statistics and vital records.

27           (3) For the 2021-22 state fiscal year, \$255,167 is appropriated to  
28 the department of revenue. This appropriation is from the marijuana cash  
29 fund created in section 44-10-801 (1)(a), C.R.S. To implement this act,  
30 the department may use this appropriation as follows:

31           (a) \$159,461 for use by the specialized business group for  
32 marijuana enforcement, which amount is based on an assumption that the  
33 subdivision will require an additional 1.5 FTE; and

34           (b) \$95,706 for the purchase of legal services.

35           (4) For the 2021-22 state fiscal year, \$95,706 is appropriated to  
36 the department of law. This appropriation is from reappropriated funds  
37 received from the department of revenue under subsection (3)(b) of this  
38 section and is based on an assumption that the department of law will  
39 require an additional 0.5 FTE. To implement this act, the department of  
40 law may use this appropriation to provide legal services for the

- 3 Page 1, line 102, strike "CONSUMPTION." and substitute "CONSUMPTION,
- 4 AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION."
