16 TO FORTY THOUSAND DOLLARS AND LESS THAN FIFTY THOUSAND  
17 DOLLARS;

18 (E) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
19 TO FIFTY THOUSAND DOLLARS AND LESS THAN SEVENTY THOUSAND  
20 DOLLARS;

21 (F) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
22 TO SEVENTY THOUSAND DOLLARS AND LESS THAN ONE HUNDRED  
23 THOUSAND DOLLARS;

24 (G) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
25 TO ONE HUNDRED THOUSAND DOLLARS AND LESS THAN ONE HUNDRED  
26 FIFTY THOUSAND DOLLARS;

27 (H) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
28 TO ONE HUNDRED FIFTY THOUSAND DOLLARS AND LESS THAN TWO  
29 HUNDRED THOUSAND DOLLARS;

30 (I) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
31 TO TWO HUNDRED THOUSAND DOLLARS AND LESS THAN TWO HUNDRED  
32 FIFTY THOUSAND DOLLARS;

33 (J) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
34 TO TWO HUNDRED FIFTY THOUSAND DOLLARS AND LESS THAN FIVE  
35 HUNDRED THOUSAND DOLLARS;

36 (K) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
37 TO FIVE HUNDRED THOUSAND DOLLARS AND LESS THAN ONE MILLION

1 DOLLARS; AND  
2 (L) FEDERAL ADJUSTED GROSS INCOME GREATER THAN OR EQUAL  
3 TO ONE MILLION DOLLARS; AND".
