

SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Pettersen

1 Amend printed bill, page 7, strike lines 15 through 27 and substitute:

2 "(a) "FAMILY-PLANNING-RELATED SERVICES" MEANS SERVICES
3 PROVIDED IN A FAMILY PLANNING SETTING AS PART OF OR AS A FOLLOW-UP
4 TO A FAMILY PLANNING VISIT, INCLUDING:

5 (I) MEDICALLY NECESSARY EVALUATIONS OR PREVENTIVE
6 SERVICES, SUCH AS TOBACCO UTILIZATION SCREENING, COUNSELING,
7 TESTING, AND CESSATION SERVICES;

8 (II) CERVICAL CANCER SCREENING AND PREVENTION;

9 (III) DIAGNOSIS OR TREATMENT OF A SEXUALLY TRANSMITTED
10 INFECTION OR SEXUALLY TRANSMITTED DISEASE, AND MEDICATION AND
11 SUPPLIES TO PREVENT A SEXUALLY TRANSMITTED INFECTION OR SEXUALLY
12 TRANSMITTED DISEASE; AND

13 (IV) ANY OTHER MEDICAL DIAGNOSIS, TREATMENT, OR
14 PREVENTIVE SERVICE THAT IS ROUTINELY PROVIDED PURSUANT TO A
15 FAMILY PLANNING VISIT.

16 (b) "FAMILY PLANNING SERVICES" MEANS ALL SERVICES COVERED
17 BY THE FEDERAL TITLE X FAMILY PLANNING PROGRAM, REGARDLESS OF
18 AN INDIVIDUAL'S AGE, SEX, OR GENDER IDENTITY, OR THE AGE, SEX, OR
19 GENDER IDENTITY OF THE INDIVIDUAL'S PARTNER, INCLUDING BUT NOT
20 LIMITED TO:

21 (I) ALL CONTRACEPTION, AS DEFINED IN SECTION 2-4-401 (1.5);

22 (II) HEALTH-CARE AND COUNSELING SERVICES FOCUSED ON
23 PREVENTING, DELAYING, OR PLANNING FOR A PREGNANCY;

24 (III) FOLLOW-UP VISITS TO EVALUATE OR MANAGE PROBLEMS
25 ASSOCIATED WITH CONTRACEPTIVE METHODS;

26 (IV) STERILIZATION SERVICES, REGARDLESS OF AN INDIVIDUAL'S
27 SEX; AND

28 (V) BASIC FERTILITY SERVICES."
