SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB21-056 be amended as follows:

1 Amend printed bill, page 3, line 17, strike "(3)(d.5)(III)(D) and (6)" and
2 substitute "(3)(d.5)(III)(D), (6), and (7)".

3 Page 6, line 26, after the period, insert "THE VOLUNTEER OR SCHOOL
4 PERSONNEL SHALL ADMINISTER THE MEDICAL MARIJUANA PURSUANT TO
5 THE INSTRUCTIONS OR PLAN FOR ADMINISTRATION FROM ONE OF THE
6 STUDENT'S RECOMMENDING PHYSICIANS, INCLUDING DOSING, TIMING, AND
7 DELIVERY ROUTE INSTRUCTION."

8 Page 7, after line 22 insert:

9 "(7) NOTHING IN THIS SECTION REQUIRES SCHOOL PERSONNEL TO
10 VOLUNTEER TO POSSESS, ADMINISTER, OR ASSIST IN THE ADMINISTRATION
11 OF MEDICAL MARIJUANA IN A NONSMOKEABLE FORM TO ANY STUDENT
12 WITH A VALID RECOMMENDATION FOR MEDICAL MARIJUANA. A SCHOOL
13 MAY NOT REQUIRE SCHOOL PERSONNEL TO POSSESS, ADMINISTER, OR
14 ASSIST IN THE ADMINISTRATION OF MEDICAL MARIJUANA IN A
15 NONSMOKEABLE FORM AGAINST THEIR WILL, NOR MAY A SCHOOL
16 DISCIPLINE SCHOOL PERSONNEL FOR REFUSING TO POSSESS, ADMINISTER,
17 OR ASSIST IN THE ADMINISTRATION OF MEDICAL MARIJUANA UNDER THIS
18 SECTION."

19 Page 8, after line 23 insert:

20 "SECTION 5. In Colorado Revised Statutes, **add** 12-30-116 as
21 follows:

22 **12-30-116. Protection for administering medical marijuana at**
23 **school.** A PERSON LICENSED PURSUANT TO THIS TITLE 12 IS NOT SUBJECT
24 TO ANY DISCIPLINARY ACTION RELATED TO THE ADMINISTRATION OF
25 MEDICAL MARIJUANA IN A NONSMOKEABLE FORM IN A SCHOOL TO A
26 STUDENT WITH A VALID MEDICAL MARIJUANA RECOMMENDATION
27 PURSUANT TO SECTION 22-1-119.3."
