- Page 21, line 1, change the colon to a semicolon and add "AND, FOR
- 19 LOANS REFERRED TO COLLECTIONS BEFORE THE EFFECTIVE DATE OF THIS
- 20 PART 2, THE COLLECTION AGENCY SHALL HAVE THIRTY DAYS TO ACQUIRE
- 21 THE INFORMATION FROM THE PRIVATE EDUCATION LENDER:".
- Page 21, line 10, strike "AT DEFAULT;" and substitute "WHEN THE PRIVATE
- 23 EDUCATION LOAN WAS REFERRED TO COLLECTIONS;".

- 25 COLLECTION AGENCY MAY RELY ON INFORMATION PROVIDED BY THE

- 14 EDUCATION LOAN BORROWER DISPUTES THE OWNERSHIP OR ASSIGNMENT
- 15 OF THE LOAN, THE COLLECTION AGENCY SHALL BEAR THE BURDEN OF
- 16 ESTABLISHING THE UNBROKEN CHAIN OF OWNERSHIP, BEGINNING WITH THE
- 17 TRUE ORIGINAL LENDER TO THE FIRST SUBSEQUENT LOAN HOLDER AND
- 18 EACH ADDITIONAL LOAN HOLDER.".

- 20 BUYER".
- 21 Page 24, line 10, strike "COMMENCING" and substitute "THAT, ON OR
- 22 AFTER THE EFFECTIVE DATE OF THIS PART 2, COMMENCES".
- 23 Page 24, line 17, strike "FIRST PARTIAL OR MISSED PAYMENT;" and
- 24 substitute "PARTIAL OR MISSED PAYMENT THAT LED TO THE REFERRAL OF
- 25 THE PRIVATE EDUCATION LOAN TO COLLECTIONS;".
- 26 Page 25, line 1, strike "A" and substitute "(a) FOR LITIGATION
- 27 PROCEEDINGS COMMENCED ON OR AFTER THE EFFECTIVE DATE OF THIS
- 28 PART 2, A".
- 29 Page 25, after line 4 insert:
- 30 "(b) FOR LITIGATION PROCEEDINGS COMMENCED BEFORE THE
- 31 EFFECTIVE DATE OF THIS PART 2, THE COURT SHALL NOT ENTER A
- 32 JUDGMENT UNTIL THE COLLECTION AGENCY IS PROVIDED AN OPPORTUNITY
- 33 TO SUBMIT PROOF OF COMPLIANCE WITH SECTION 5-20-212.".
