SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business, Labor, & Technology.

SB21-060 be amended as follows:

- 1 Amend printed bill, page 2, strike lines 2 and 3 and substitute:
 - 2 "SECTION 1. In Colorado Revised Statutes, 40-15-102, **add**
 - 3 (5.7) as follows:".
- 4 Page 3, strike lines 1 through 12.
- 5 Page 3, strike lines 21 and 22 and substitute "(10.5); **repeal** (10.6); and
- 6 **add** (6.5) and (8)(a)(V) as".
- 7 Page 3, strike line 27.
- 8 Strike pages 4 and 5.
- 9 Page 6, strike lines 1 through 8.
- 10 Page 6, line 12, strike "THAT EITHER:" and substitute "THAT:".
- 11 Page 6, line 17, strike "OR".
- 12 Page 6, line 19, strike "INCOME." and substitute "INCOME; OR
- 13 (III) ARE LOCATED IN CRITICALLY UNSERVED AREAS OF THE STATE.
- 14 A HOUSEHOLD IS ELIGIBLE FOR REIMBURSEMENT UNDER THIS SUBSECTION
- 15 (6.5)(a)(III) ONLY:
 - 16 (A) FOR BROADBAND SERVICE PROVIDED BY A SATELLITE
 - 17 PROVIDER;
 - 18 (B) WITH RESPECT TO THE HOUSEHOLD'S PRIMARY RESIDENCE;
 - 19 AND
 - 20 (C) IF THE BOARD DETERMINES THAT BUILD-OUT OF BROADBAND
 - 21 SERVICE IS UNLIKELY.".
- 22 Page 7, strike lines 11 through 27.
- 23 Page 8, strike lines 1 through 23 and substitute:
 - 24 "(a) (V) ON OR BEFORE NOVEMBER 1, 2021, THE DEPARTMENT OF
 - 25 TRANSPORTATION SHALL SUBMIT A MAP OR MAPS TO THE BOARD
 - 26 IDENTIFYING ANY BROADBAND INFRASTRUCTURE OR EXCESS CAPACITY
 - 27 THAT THE DEPARTMENT COULD LEASE FOR THE DEPLOYMENT OF
 - 28 BROADBAND IN THE STATE.".

1 Page 8, line 24, strike "(a)" and substitute "(a)".

2 Page 9, after line 2 insert:

3 "(b) (I) NOTWITHSTANDING SUBSECTION (10.5)(a) OF THIS
4 SECTION, THE BOARD SHALL RECEIVE ANY FEDERAL COVID-19 FUNDING
5 AWARDED TO THE STATE FOR BROADBAND DEPLOYMENT AND SHALL
6 EXPEND THE MONEY IN ACCORDANCE WITH FEDERAL GUIDELINES FOR USE
7 OF THE MONEY, EVEN IF SUCH USE OF THE MONEY FALLS OUTSIDE THE
8 REQUIREMENTS FOR USE OF BROADBAND DEPLOYMENT GRANT MONEY SET
9 FORTH IN THIS SECTION. THE HCSM THIRD-PARTY CONTRACTOR SHALL
10 MAINTAIN ANY FEDERAL COVID-19 FUNDING AWARDED FOR BROADBAND
11 DEPLOYMENT IN A SEPARATE ACCOUNT OF THE HCSM THAT IS DEDICATED
12 TO ALLOCATING FEDERAL COVID-19 FUNDING FOR BROADBAND
13 DEPLOYMENT. THE COMMISSION IS AUTHORIZED TO DISBURSE ANY MONEY
14 FROM THE ACCOUNT AS DIRECTED BY THE BOARD.

15 (II) AS USED IN THIS SUBSECTION (10.5)(b):

16 (A) "COVID-19 PANDEMIC" MEANS THE PANDEMIC RESULTING
17 FROM THE CORONAVIRUS DISEASE 2019 CAUSED BY THE SEVERE ACUTE
18 RESPIRATORY SYNDROME CORONAVIRUS 2, ALSO KNOWN AS
19 SARS-CoV-2.

20 (B) "FEDERAL COVID-19 FUNDING" MEANS FEDERAL MONEY
21 AWARDED TO THE STATE IN RESPONSE TO, AND FOR THE PURPOSE OF
22 HELPING THE STATE RECOVER FROM, THE COVID-19 PANDEMIC.

23 (III) THIS SUBSECTION (10.5)(b) IS REPEALED, EFFECTIVE
24 SEPTEMBER 1, 2025."

25 Page 12, strike lines 19 through 27.

26 Strike pages 13 through 15.

27 Page 16, strike lines 1 through 3.

28 Renumber succeeding section accordingly.
