1 Amend the Appropriations Committee Report, dated June 4, 2021, page  
2 1, strike line 1 and substitute:

3 "Amend reengrossed bill, page 4, strike line 12 and substitute "PERSON  
4 MAY ASSERT A CLAIM:

5 (I) IN DISTRICT COURT FOR INJUNCTIVE AND".

6 Page 4 of the bill, line 15, strike "COSTS." and substitute "COSTS; OR

7 (II) WITH THE DIVISION PURSUANT TO RULES ADOPTED BY THE  
8 DIRECTOR. THE DIRECTOR MAY INVESTIGATE AND ORDER ALL REMEDIES  
9 AVAILABLE IN DISTRICT COURT OR MAY DECLINE TO INVESTIGATE AND  
10 THUS AUTHORIZE THE COMPLAINANT TO FILE SUIT IN DISTRICT COURT. A  
11 DECISION BY THE DIRECTOR TO DECLINE TO INVESTIGATE MUST BE MADE  
12 WITHIN NINETY DAYS AFTER THE CLAIM IS FILED AS ESTABLISHED BY RULE  
13 OF THE DIRECTOR. THE STATUTE OF LIMITATIONS IS TOLLED FOR THE  
14 PURPOSE OF FILING A CLAIM IN DISTRICT COURT FROM THE DATE THAT THE  
15 CLAIM IS ASSERTED UNTIL NINETY DAYS AFTER THE DIRECTOR DECLINES  
16 TO INVESTIGATE THE CLAIM."

17 Page 17 of the bill, strike line 10 and substitute "WORKER DUE TO A  
18 VIOLATION OF THIS PART 2 MAY:

19 (I) COMMENCE AN ACTION".

20 Page 17, strike line 12 and substitute "VIOLATION OF THIS PART 2; OR

21 (II) ASSERT A CLAIM WITH THE DIVISION PURSUANT TO RULES  
22 ADOPTED BY THE DIRECTOR OF THE DIVISION AGAINST AN AGRICULTURAL  
23 EMPLOYER. THE DIRECTOR MAY INVESTIGATE AND ORDER ALL REMEDIES  
24 AVAILABLE IN DISTRICT COURT OR MAY DECLINE TO INVESTIGATE AND  
25 THUS AUTHORIZE THE COMPLAINANT TO FILE SUIT IN DISTRICT COURT. A  
26 DECISION BY THE DIRECTOR TO DECLINE TO INVESTIGATE MUST BE MADE  
27 WITHIN NINETY DAYS AFTER THE CLAIM IS FILED AS ESTABLISHED BY RULE  
28 OF THE DIRECTOR. THE STATUTE OF LIMITATIONS IS TOLLED FOR THE  
29 PURPOSE OF FILING A CLAIM IN DISTRICT COURT FROM THE DATE THAT THE  
30 CLAIM IS ASSERTED UNTIL NINETY DAYS AFTER THE DIRECTOR DECLINES  
31 TO INVESTIGATE THE CLAIM."

32 Page 25 of the bill, after line 2 insert:".
