SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

SB21-105 be amended as follows:

- 1 Amend printed bill, page 2, line 4, after "(3)(a)(V)," insert "(3)(a)(VI),".
- 2 Page 4, line 4, after "CONDUCTING" insert "PLANNING AND".
- 3 Page 4, line 5, after "OFFICIALS," insert "INCLUDING COUNTY
- 4 COMMISSIONERS;".
- 5 Page 4, line 6, change the comma to a semi-colon.
- 6 Page 5, line 11, strike "AND".
- 7 Page 5, line 17, strike "STATES." and substitute "STATES; AND
- 8 (VI) INPUT FROM COUNTY COMMISSIONERS REPRESENTING
- 9 COUNTIES WEST OF THE CONTINENTAL DIVIDE WHERE GRAY WOLVES WILL
- 10 BE RELEASED.".
- 11 Page 5, after line 18, insert:
- 12 "(I) CONVENE AN ADVISORY COMMITTEE OF COUNTY
- 13 COMMISSIONERS FROM COUNTIES WEST OF THE CONTINENTAL DIVIDE
- 14 WHERE GRAY WOLVES WILL BE RELEASED. THE DIVISION SHALL PROVIDE
- 15 THE ADVISORY COMMITTEE WITH A PRELIMINARY DRAFT PLAN AND ACCESS
- 16 TO INFORMATION TO ENABLE FULL PARTICIPATION IN DEVELOPING THE
- 17 PRELIMINARY DRAFT PLAN. THE COMMISSION SHALL USE FEEDBACK FROM
- 18 THE ADVISORY COMMITTEE TO ASSURE CONSISTENCY OF THE PRELIMINARY
- 19 DRAFT PLAN WITH COUNTY PLANS, POLICY, AND ORDINANCES TO MAINTAIN
- 20 VALUED CUSTOMS, VARIED CULTURES, AND COMMUNITY STABILITY. THE
- 21 COMMISSION SHALL PUBLICIZE AND SEEK FEEDBACK CONCERNING THE
- 22 PRELIMINARY DRAFT PLAN AND, BASED ON THE FEEDBACK, RELEASE A
- 23 DRAFT PLAN FOR PUBLIC COMMENT AND HOLD HEARINGS AS SPECIFIED IN
- 24 SUBSECTION (3.4)(a)(II) OF THIS SECTION.".
- 25 Renumber succeeding subparagraphs accordingly.
- 26 Page 5, line 27, strike "(3.4)(a)(I)" and substitute "(3.4)(a)(II)".
- 27 Page 6, line 6, strike "(3.4)(a)(II)" and substitute "(3.4)(a)(III)".
