

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB21-151 be amended as follows:

1 Amend printed bill, page 2, strike lines 5 through 8 and substitute  
2 **"training. (8)(a)** EACH LOCAL EDUCATION PROVIDER SHALL SUBMIT TO  
3 THE DEPARTMENT, AND UPDATE AS NECESSARY TO REMAIN CURRENT, THE  
4 FOLLOWING INFORMATION, AND THE DEPARTMENT SHALL POST THE  
5 INFORMATION ON THE DEPARTMENT'S WEBSITE, AS PROVIDED IN SECTION  
6 22-7-1209 (9):".

7 Page 3, strike lines 6 through 12 and substitute:

8 "(b) EACH LOCAL EDUCATION PROVIDER SHALL INCLUDE ON ITS  
9 WEBSITE A LINK TO THE PAGE ON WHICH THE MATERIALS DESCRIBED IN  
10 SUBSECTION (8)(a) OF THIS SECTION ARE POSTED ON THE DEPARTMENT'S  
11 WEBSITE. THE LINK MUST BE EASILY IDENTIFIABLE IN A LOCATION ON THE  
12 LOCAL EDUCATION PROVIDER'S WEBSITE THAT IS IDENTIFIED AS RELATING  
13 TO STUDENT LITERACY OR THE "COLORADO READ ACT". THE LOCAL  
14 EDUCATION PROVIDER SHALL ALSO ENSURE THAT EACH SCHOOL-LEVEL  
15 WEBSITE FOR A SCHOOL OPERATED BY THE LOCAL EDUCATION PROVIDER  
16 INCLUDES THE LINK TO THE INFORMATION ON THE DEPARTMENT'S  
17 WEBSITE.

18 **SECTION 2.** In Colorado Revised Statutes, 22-7-1209, **add** (9)  
19 as follows:

20 **22-7-1209. State board - rules - department - duties.** (9) THE  
21 DEPARTMENT SHALL POST ON ITS WEBSITE THE INFORMATION SUBMITTED  
22 BY LOCAL EDUCATION PROVIDERS PURSUANT TO SECTION 22-7-1208 (8).  
23 THE DEPARTMENT SHALL ENSURE THAT THE INFORMATION IS POSTED IN A  
24 USER-FRIENDLY FORMAT AND IN A LOCATION ON THE WEBSITE EASILY  
25 IDENTIFIED AS RELATING TO STUDENT LITERACY OR THE "COLORADO  
26 READ ACT". THE DEPARTMENT SHALL NOTIFY THE LOCAL EDUCATION  
27 PROVIDERS OF THE SPECIFIC INTERNET ADDRESS FOR THE PAGE ON WHICH  
28 THE INFORMATION IS POSTED AND SHALL UPDATE THE INFORMATION IN A  
29 TIMELY MANNER AS IT RECEIVES UPDATES FROM THE LOCAL EDUCATION  
30 PROVIDERS."

31 Renumber succeeding section accordingly.
