SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB21-160 be amended as follows:

1 Amend printed bill, page 4, line 4, after "(3)" insert "and (5)".

2 Page 4, after line 24 insert:

3 "(5) (a) The self-nomination and acceptance form or letter must
4 be verified and processed substantially as provided in ~~section 1-4-908~~
5 THIS SUBSECTION (5)(a) AND SUBSECTION (5)(b) OF THIS SECTION, a protest
6 on such a form or letter must be determined substantially as provided in
7 sections 1-4-909 and 1-4-911, and ~~cure of such a form or letter must be~~
8 ~~allowed substantially as provided for in section 1-4-912; except that AN~~
9 INSUFFICIENT FORM OR LETTER MAY BE CURED BY SUBMITTING AN
10 amended self-nomination and acceptance form or letter ~~may be accepted~~
11 ~~by~~ TO the designated election official ~~until~~ BEFORE the normal close of
12 business on the sixty-seventh day before an election.

13 (b) UPON FILING, THE DESIGNATED ELECTION OFFICIAL SHALL
14 REVIEW THE INFORMATION IN THE SELF-NOMINATION AND ACCEPTANCE
15 FORM OR LETTER AND VERIFY THE INFORMATION AGAINST THE
16 REGISTRATION RECORDS, AND, WHERE APPLICABLE, THE COUNTY
17 ASSESSOR'S RECORDS.

18 (c) IF, WHILE VERIFYING A SIGNER'S INFORMATION AGAINST THE
19 REGISTRATIONS RECORDS IN ACCORDANCE WITH SUBSECTIONS (5)(a) AND
20 (5)(b) OF THIS SECTION, THE DESIGNATED ELECTION OFFICIAL FINDS THAT
21 THE SIGNER PROVIDED HIS OR HER MAILING ADDRESS RATHER THAN HIS OR
22 HER RESIDENCE ADDRESS AS REQUIRED UNDER SUBSECTION (3) OF THIS
23 SECTION, THE DESIGNATED ELECTION OFFICIAL MAY ACCEPT THE
24 SELF-NOMINATION FORM IF THE DESIGNATED ELECTION OFFICIAL IS ABLE
25 TO LOCATE THE SIGNER'S RECORD IN THE STATEWIDE VOTER REGISTRATION
26 DATABASE AND DETERMINE THAT THE SELF-NOMINATION FORM IS
27 OTHERWISE SUFFICIENT.

28 (d) AFTER REVIEW, THE DESIGNATED ELECTION OFFICIAL SHALL
29 PROVIDE NOTIFICATION OF THE SUFFICIENCY OR INSUFFICIENCY OF THE
30 CANDIDATE."

31 Page 5, lines 3 and 4, strike "WHO RESIDES WITHIN THE BOUNDARIES OF
32 THE LOCAL GOVERNMENT AND".

33 Page 5, line 23, strike "owners'" and substitute "~~owners'~~ OWNERS".
