Second Reading

1 Amend the Health and Human Services Committee Report, dated March
2 17, 2021, page 2, strike line 11 and substitute:

3 "Page 14 of the printed bill, strike lines 11 through 14 and substitute:

4 "(a) EACH CARRIER AND EACH PHARMACY BENEFIT MANAGEMENT
5 FIRM ACTING ON BEHALF OF A CARRIER SHALL REPORT TO THE ALL-PAYER
6 HEALTH CLAIMS DATABASE THE FOLLOWING INFORMATION:".

7 Page 15 of the bill, line 4, strike "AND".

8 Page 15 of the bill, line 6, strike "REBATES." and substitute "REBATES;".

9 Page 15 of the bill, strike lines 7 through 13 and substitute:

10 "(VIII) THE TOTAL SPENDING FOR EACH OF THE FOLLOWING
11 CATEGORIES OF PRESCRIPTION DRUGS:".

12 Page 15 of the bill, line 14, strike "(I)" and substitute "(A)".

13 Page 15 of the bill, line 15, strike "(II)" and substitute "(B)".

14 Page 15 of the bill, line 17, strike "(III)" and substitute "(C)".

15 Page 15 of the bill, line 19, strike "(IV)" and substitute "(D)".

16 Page 15 of the bill, line 21, strike "(V)" and substitute "(E)".

17 Page 15 of the bill, line 23, strike "(VI)" and substitute "(F)".

18 Page 15 of the bill, line 25, strike "(VII)" and substitute "(G)".

19 Page 15 of the bill, line 26, strike "SETTING." and substitute "SETTING;
20 AND".

21 Page 15 of the bill, strike line 27 and substitute:

22 "(IX) THE TOTAL SPENDING FOR THE PRESCRIPTION DRUGS
23 DESCRIBED IN SUBSECTION (1)(a)(VIII) OF THIS SECTION PAID FOR BY A
24 CARRIER PURSUANT TO A HEALTH BENEFIT PLAN ISSUED UNDER PART 2, 3,
25 OR 4 OF THIS ARTICLE 16 DURING THE IMMEDIATELY PRECEDING

1 CALENDAR YEAR FOR EACH OF THE FOLLOWING MARKET SECTORS:".

2 Page 16 of the bill, strike lines 1 through 9.

3 Page 16 of the bill, line 10, strike "(I)" and substitute "(A)".

4 Page 16 of the bill, line 11, strike "(II)" and substitute "(B)".

5 Page 16 of the bill, line 12, strike "(III)" and substitute "(C)".

6 Page 16 of the bill, after line 12, insert:

7 "(b) IF THE ALL-PAYER HEALTH CLAIMS DATABASE DOES NOT
8 COLLECT AND MAINTAIN THE DATA THAT IS REQUIRED TO BE REPORTED TO
9 THE DATABASE PURSUANT TO SUBSECTION (1)(a) OF THIS SECTION, THE
10 ADMINISTRATOR OF THE ALL-PAYER HEALTH CLAIMS DATABASE SHALL
11 AMEND THE REQUIREMENTS REGARDING THE DATA TO BE SUBMITTED TO
12 THE DATABASE PURSUANT TO SECTION 25.5-1-204 (5) TO INCLUDE THE
13 DATA REQUIRED BY SUBSECTION (1)(a) OF THIS SECTION DURING THE NEXT
14 UPDATE OF SUCH REQUIREMENTS, BUT NO LATER THAN JUNE 1, 2022.

15 (2) THE ADMINISTRATOR OF THE ALL-PAYER HEALTH CLAIMS
16 DATABASE SHALL PROVIDE TO THE COMMISSIONER, IN A FORM AND
17 MANNER DETERMINED BY THE COMMISSIONER, THE INFORMATION THAT IS
18 REPORTED TO THE DATABASE BY CARRIERS AND PHARMACY BENEFIT
19 MANAGEMENT FIRMS PURSUANT TO SUBSECTION (1)(a) OF THIS SECTION."

20 Page 16 of the bill, strike line 13 and substitute:

21 "(3) (a) EXCEPT AS PROVIDED IN SUBSECTION (3)(b) OF THIS".

22 Page 17 of the bill, line 5, strike "(3)" and substitute "(4)".
