- 3 Page 11, line 19, strike "10-16-1314 (1)(g)." and substitute "10-16-1313
4 (1)(g).".
- 5 Page 13, line 26, strike "ESTABLISH" and substitute "RECOMMEND".
- 6 Page 21, line 16, after "**board** - " insert "**recommended**".
- 7 Page 21, line 17, strike "ESTABLISH" and substitute "RECOMMEND".
- 8 Page 21, line 23, strike "ESTABLISH" and substitute "RECOMMEND".
- 9 Page 21, line 26, strike "ESTABLISHING" and substitute "RECOMMENDING".
- 10 Page 22, strike line 9 and substitute:
11 "(3) A RECOMMENDED UPPER PAYMENT LIMIT MAY APPLY TO
12 PURCHASES OF AND".
- 13 Page 22, after line 13 insert:
14 "(4) LEGISLATIVE APPROVAL IS REQUIRED BEFORE A
15 RECOMMENDED UPPER PAYMENT LIMIT MAY BY ENFORCED FOR PURCHASE
16 OF AND PAYER REIMBURSEMENTS FOR A PRESCRIPTION DRUG.".
- 17 Renumber succeeding subsections accordingly.
- 18 Page 23, strike lines 7 and 8 and substitute "A RECOMMENDATION OF THE
19 BOARD MAY APPEAL THE RECOMMENDATION WITHIN SIXTY DAYS AFTER
20 THE RECOMMENDATION IS MADE. THE BOARD SHALL CONSIDER THE
21 APPEAL".
- 22 Page 23, line 17, strike " DECISION" and substitute "RECOMMENDATION".
- 23 Page 23, strike line 19 and substitute "PERSON AGGRIEVED BY OR WHO
24 DISPUTES A FINAL RECOMMENDATION OF THE BOARD MAY PETITION".
- 25 Page 26, strike line 23 and substitute "THE USE OF AN UPPER PAYMENT
26 LIMIT RECOMMENDED BY THE".
- 27 Page 27, line 3, after "THE" insert "POTENTIAL".

- 1 Page 27, line 5, strike "ESTABLISHED" and substitute "RECOMMENDED".
- 2 Page 27, line 6, strike "WERE" and substitute "WOULD BE".
- 3 Page 27, strike lines 12 through 27.
- 4 Page 28, strike lines 1 and 2.
- 5 Renumber succeeding C.R.S. sections accordingly.
- 6 Page 28, strike lines 6 and 7 and substitute "STATE A PRESCRIPTION DRUG
7 FOR WHICH THE BOARD HAS RECEIVED LEGISLATIVE APPROVAL TO APPLY
8 AN UPPER PAYMENT LIMIT TO ALL PURCHASES OF AND PAYER
9 REIMBURSEMENTS FOR THE PRESCRIPTION DRUG SHALL PROVIDE".
- 10 Page 28, strike lines 21 and 22 and substitute "PRESCRIPTION DRUG FOR
11 WHICH THE BOARD HAS RECEIVED LEGISLATIVE APPROVAL TO APPLY AN
12 UPPER PAYMENT LIMIT TO ALL PURCHASES OF AND PAYER
13 REIMBURSEMENTS FOR THE PRESCRIPTION DRUG PURSUANT TO SECTION
14 10-16-1307".
- 15 Page 29, line 18, strike "ESTABLISHED" and substitute "RECOMMENDED".
- 16 Page 1, line 104, strike "ESTABLISH" and substitute "RECOMMEND".
