

SENATE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 30, after line 9 insert:

2 "(3) (a) THE CHAIR OF THE BOARD SHALL PRESENT TO THE JOINT
3 HEALTH AND INSURANCE COMMITTEE OF THE HOUSE OF REPRESENTATIVES
4 AND HEALTH AND HUMAN SERVICES COMMITTEE OF THE SENATE, OR ANY
5 SUCCESSOR COMMITTEES, WHICH PRESENTATION OCCURS PURSUANT TO
6 THE "STATE MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE, AND
7 TRANSPARENT (SMART) GOVERNMENT ACT", PART 2 OF ARTICLE 7 OF
8 TITLE 2, INFORMATION CONCERNING ANY PRESCRIPTION DRUG FOR WHICH
9 THE BOARD ESTABLISHED AN UPPER PAYMENT LIMIT DURING THE
10 PRECEDING CALENDAR YEAR. THE CHAIR SHALL SUMMARIZE FOR THE
11 COMMITTEE MEMBERS:

12 (I) THE AFFORDABILITY REVIEW OF THE PRESCRIPTION DRUG,
13 INCLUDING THE RESULTS OF THE BOARD'S CONSIDERATIONS AS DESCRIBED
14 IN SECTION 10-16-1306 (4) AND, IF APPLICABLE, SECTION 10-16-1306 (6);
15 AND

16 (II) THE ESTABLISHMENT OF THE UPPER PAYMENT LIMIT,
17 INCLUDING A SUMMARY OF THE METHODOLOGY USED TO ESTABLISH THE
18 UPPER PAYMENT LIMIT.

19 (b) BASED ON THE INFORMATION PRESENTED IN SUBSECTION (3)(a)
20 OF THIS SECTION, MEMBERS OF THE JOINT HEALTH AND INSURANCE
21 COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND HEALTH AND
22 HUMAN SERVICES COMMITTEE OF THE SENATE, OR ANY SUCCESSOR
23 COMMITTEES, MAY PURSUE LEGISLATION, IF THE MAJORITY OF COMMITTEE
24 MEMBERS VOTE TO PURSUE SUCH LEGISLATION, TO DISCONTINUE THE
25 UPPER PAYMENT LIMIT FOR ANY PRESCRIPTION DRUG FOR WHICH THE
26 BOARD ESTABLISHED AN UPPER PAYMENT LIMIT. ANY SUCH LEGISLATION
27 SHALL NOT COUNT AGAINST ANY LIMITATION UPON THE NUMBER OF BILLS
28 THAT A MEMBER OF THE GENERAL ASSEMBLY MAY INTRODUCE EACH
29 REGULAR LEGISLATIVE SESSION, WHICH LIMITATION MAY EXIST PURSUANT
30 TO RULES ADOPTED BY THE GENERAL ASSEMBLY."
