1 Amend printed bill, page 3, strike lines 7 through 13 and substitute:

2 "SECTION 3. In Colorado Revised Statutes, 15-18-104, **amend**  
3 (2) as follows:

4 **15-18-104. Declaration as to medical treatment.** (2) In the case  
5 of a declaration of a qualified patient known to the attending physician to  
6 be pregnant, a medical evaluation shall be made as to whether the fetus  
7 is viable. If the fetus is viable, the declaration shall be given no force or  
8 effect until the patient is no longer pregnant, UNLESS THE QUALIFIED  
9 PATIENT HAS EXPRESSLY PROVIDED THAT THE DECLARATION REMAIN IN  
10 EFFECT WHILE THE PATIENT IS PREGNANT WITH A VIABLE FETUS."
