**PURPOSE:** Increases appropriations by \$41.3 million General Fund in the Department of **Transportation** and adds a related footnote to specify the General Assembly's intent that the funds be used for improvements to

Highway 141 in Mesa County. Decreases appropriations by \$73.6 million total funds, including \$41.3 million General Fund, for **all departments** from salary survey, short term disability, amortization equalization disbursement, and supplemental amortization equalization disbursement for the elimination of the 3.0 percent across-the-board salary survey increase.
