

## SENATE FLOOR AMENDMENT

Second Reading

- 1 Amend printed bill, page 3, line 3, after "(1.5)" insert "and (1.7)".
- 2 Page 3, line, 13, strike "THE" and substitute "EXCEPT AS OTHERWISE  
3 REQUIRED BY SUBSECTION (1.7) OF THIS SECTION, THE".
- 4 Page 3, strike lines 16 through 19 and substitute:
- 5 "(b) MAILING THE NOTICE, AT THE LOWEST COST OPTION, TO EACH  
6 ADDRESS AT WHICH ONE OR MORE ACTIVE REGISTERED ELECTORS OF THE  
7 LOCAL GOVERNMENT RESIDES AS SPECIFIED IN THE REGISTRATION LIST  
8 PROVIDED BY THE COUNTY CLERK AND RECORDER AS OF THE DATE THAT  
9 IS ONE HUNDRED FIFTY DAYS PRIOR TO THE DATE OF THE REGULAR LOCAL  
10 GOVERNMENT ELECTION;".
- 11 Page 3, line 23, strike "SPECIAL DISTRICT" and substitute "LOCAL  
12 GOVERNMENT".
- 13 Page 3, line 24, strike "SPECIAL DISTRICT;" and substitute "LOCAL  
14 GOVERNMENT;".
- 15 Page 3, strike line 26 and substitute "LOCAL GOVERNMENT; OR".
- 16 Page 4, strike lines 1 and 2.
- 17 Page 4, line 3, strike "SPECIAL DISTRICT" and substitute "LOCAL  
18 GOVERNMENT".
- 19 Page 4, line 7, strike "SPECIAL DISTRICT" and substitute "LOCAL  
20 GOVERNMENT".
- 21 Page 4, line 9, strike "SPECIAL DISTRICT" and substitute "LOCAL  
22 GOVERNMENT".
- 23 Page 4, after line 11 insert:
- 24 "(1.7) (a) IN THE CASE OF ANY METROPOLITAN DISTRICT THAT WAS  
25 ORGANIZED AFTER JANUARY 1, 2000, IN ACCORDANCE WITH TITLE 32, THE  
26 NOTICE REQUIRED BY SUBSECTION (1) OF THIS SECTION MUST BE MADE BY  
27 EMAILING THE NOTICE TO EACH ACTIVE REGISTERED ELECTOR OF THE  
28 METROPOLITAN DISTRICT AS SPECIFIED IN THE REGISTRATION LIST  
29 PROVIDED BY THE COUNTY CLERK AND RECORDER AS OF THE DATE THAT

1 IS ONE HUNDRED FIFTY DAYS PRIOR TO THE DATE OF THE REGULAR LOCAL  
2 GOVERNMENT ELECTION. WHERE THE ACTIVE REGISTERED ELECTOR DOES  
3 NOT HAVE AN E-MAIL ADDRESS ON FILE FOR SUCH PURPOSE WITH THE  
4 COUNTY CLERK AND RECORDER AS OF THE DATE THAT IS NOT LATER THAN  
5 ONE HUNDRED FIFTY DAYS PRIOR TO THE DATE OF THE REGULAR LOCAL  
6 GOVERNMENT ELECTION, THE PUBLIC NOTICE REQUIRED BY SUBSECTION  
7 (1) OF THIS SECTION MUST BE MADE BY MAILING THE NOTICE, AT THE  
8 LOWEST COST OPTION, TO EACH ADDRESS AT WHICH ONE OR MORE ACTIVE  
9 REGISTERED ELECTORS OF THE METROPOLITAN DISTRICT RESIDES AS  
10 SPECIFIED IN THE REGISTRATION LIST PROVIDED BY THE COUNTY CLERK  
11 AND RECORDER AS OF THE DATE THAT IS ONE HUNDRED FIFTY DAYS PRIOR  
12 TO THE DATE OF THE REGULAR LOCAL GOVERNMENT ELECTION.

13 (b) IN ADDITION TO THE PUBLIC NOTICE REQUIRED BY SUBSECTION  
14 (1.7)(a) OF THIS SECTION, THE DESIGNATED ELECTION OFFICIAL SHALL  
15 ALSO PROVIDE PUBLIC NOTICE BY ANY ONE OF THE FOLLOWING MEANS:

16 (I) PUBLICATION AS DEFINED IN SUBSECTION (2) OF THIS SECTION;

17 (II) INCLUDING THE NOTICE AS A PROMINENT PART OF A  
18 NEWSLETTER, ANNUAL REPORT, BILLING INSERT, BILLING STATEMENT,  
19 LETTER, VOTER INFORMATION CARD OR OTHER NOTICE OF ELECTION, OR  
20 OTHER INFORMATIONAL MAILING SENT BY THE METROPOLITAN DISTRICT  
21 TO THE ELIGIBLE ELECTORS OF THE METROPOLITAN DISTRICT;

22 (III) POSTING THE INFORMATION ON THE OFFICIAL WEBSITE OF THE  
23 METROPOLITAN DISTRICT; OR

24 (IV) FOR A METROPOLITAN DISTRICT WITH FEWER THAN ONE  
25 THOUSAND ELIGIBLE ELECTORS THAT IS WHOLLY LOCATED WITHIN A  
26 COUNTY, THE POPULATION OF WHICH IS LESS THAN THIRTY THOUSAND  
27 PEOPLE, POSTING THE NOTICE IN AT LEAST THREE PUBLIC PLACES WITHIN  
28 THE TERRITORIAL BOUNDARIES OF THE METROPOLITAN DISTRICT AND, IN  
29 ADDITION, POSTING A NOTICE IN THE OFFICE OF THE CLERK AND RECORDER  
30 OF THE COUNTY IN WHICH THE SPECIAL DISTRICT IS LOCATED. ANY SUCH  
31 NOTICES MUST REMAIN POSTED UNTIL THE DAY AFTER THE CALL FOR  
32 NOMINATIONS CLOSES."
