

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB21-292 be amended as follows:

1 Amend printed bill, page 11, line 3, strike "24-75-226," and substitute
2 "24-75-228,".

3 Page 11, after line 7 insert:

4 "(2) For the 2021-22 state fiscal year, \$1,500,000 is appropriated
5 to the department of public safety for use by the division of criminal
6 justice. This appropriation is from the economic recovery and relief cash
7 fund created in section 24-75-228, C.R.S., and of money the state receives
8 from the federal coronavirus state fiscal recovery fund. To implement this
9 act, the division may use this appropriation for the state victim
10 compensation program created in section 24-4.1-117.7, C.R.S.".

11 Page 11, line 8, strike "(2)" and substitute "(3)" and strike "\$6,500,000"
12 and substitute "\$3,500,000".

13 Page 11, line 11, strike "24-75-226," and substitute "24-75-228,".

14 Page 11, after line 14 insert:

15 "(4) For the 2021-22 state fiscal year, \$1,500,000 is appropriated
16 to the victims assistance and law enforcement fund created in section 24-
17 33.5-506 (1), C.R.S. This appropriation is from the economic recovery
18 and relief cash fund created in section 24-75-228, C.R.S., and of money
19 the state received from the federal coronavirus state fiscal recovery fund.
20 The department of public safety is responsible for the accounting related
21 to this appropriation.

22 "(5) For the 2021-22 state fiscal year, \$1,500,000 is appropriated
23 to the department of public safety for use by the division of criminal
24 justice. This appropriation is from reappropriated funds in the Colorado
25 domestic abuse program fund under subsection (4) of this section. To
26 implement this act, the division may use this appropriation for the state
27 victims assistance and law enforcement program.".

28 Renumber succeeding subsections accordingly.

29 Page 11, line 18, strike "24-75-226," and substitute "24-75-228,".

30 Page 11, strike lines 22 through 27 and substitute:

31 "(7) For the 2021-22 state fiscal year, \$5,000,000 is appropriated

1 to the Colorado domestic abuse program fund created in section 39-22-
2 802 (1), C.R.S. This appropriation is from the economic recovery and
3 relief cash fund created in section 24-75-228, C.R.S., and of money the
4 state received from the federal coronavirus state fiscal recovery fund. The
5 department of human services is responsible for the accounting related to
6 this appropriation.

7 (8) For the 2021-22 state fiscal year, \$5,000,000 is appropriated
8 to the department of human services for use by the office of self
9 sufficiency. This appropriation is from reappropriated funds in the
10 Colorado domestic abuse program fund under subsection (7) of this
11 section. To implement this act, the office may use this appropriation for
12 the domestic abuse program."

13 Page 12, strike line 1.
