## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend the Judiciary Committee Report, dated March 29, 2022, page 1,  
2 line 1, after "line 4," insert "after "(4)(a)(III)(D)," insert "(4)(a)(IV),"  
3 and".

4 Page 1, strike lines 6 through 8 and substitute:

5       ""(IV) Research and analyze the effectiveness of the treatment  
6 evaluation and treatment procedures and programs developed pursuant to  
7 this ~~article~~ ARTICLE 11.8. THE BOARD SHALL DEVELOP A DATA  
8 COLLECTION PLAN AND REQUIRE APPROVED PROVIDERS TO BEGIN DATA  
9 COLLECTION PURSUANT TO THE PLAN ADOPTED BY THE BOARD NO LATER  
10 JANUARY 1, 2023. The board shall also develop and prescribe a system for  
11 implementation of the guidelines and standards developed pursuant to  
12 ~~subparagraphs (I) and (II) of this paragraph (a)~~ SUBSECTIONS (4)(a)(I)  
13 AND (4)(a)(II) OF THIS SECTION and for tracking offenders who have been  
14 evaluated and treated pursuant to this ~~article~~ ARTICLE 11.8. In addition,  
15 the board shall develop a system for monitoring offender behaviors and  
16 offender adherence to prescribed behavioral changes. The results of such  
17 tracking and behavioral monitoring shall be a part of any analysis made  
18 pursuant to this ~~subparagraph (IV)~~ SUBSECTION (4)(a)(IV).

19       (5.5) NOTWITHSTANDING SECTION 24-1-136 (11)(a)(I), ON OR  
20 BEFORE JANUARY 31, 2023, AND ON OR BEFORE EACH JANUARY 31  
21 THEREAFTER, THE BOARD SHALL PREPARE AND PRESENT A WRITTEN".

22 Page 1, line 22, strike "AND".

23 Page 1, after line 22 insert:

24       "(d) THE BEST PRACTICES FOR THE TREATMENT AND MANAGEMENT  
25 OF DOMESTIC VIOLENCE; AND".

26 Reletter succeeding paragraph accordingly.

27 Page 1, line 23, strike "INFORMATION."." and substitute "INFORMATION,  
28 INCLUDING ANY BOARD RECOMMENDATIONS FOR LEGISLATION TO CARRY  
29 OUT THE PURPOSE AND DUTIES OF THE BOARD TO PROTECT THE  
30 COMMUNITY.".".
