## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend the Energy and Environment Committee Report, dated April 13,  
2 2022, page 2, strike lines 6 through 34 and substitute:

3 "(XIII) PAPER PRODUCTS USED FOR A PRINT PUBLICATION THAT  
4 PRIMARILY INCLUDES CONTENT DERIVED FROM PRIMARY SOURCES  
5 RELATED TO NEWS AND CURRENT EVENTS;

6 (XIV) PACKAGING MATERIAL USED TO CONTAIN A PRODUCT THAT  
7 IS REGULATED AS INFANT FORMULA, AS DEFINED IN 21 U.S.C. SEC. 321 (z),  
8 AS A MEDICAL FOOD, AS DEFINED IN 21 U.S.C. SEC. 360ee (b)(3), OR AS  
9 FORTIFIED NUTRITIONAL SUPPLEMENTS USED FOR INDIVIDUALS WHO  
10 REQUIRE SUPPLEMENTAL OR SOLE SOURCE NUTRITION TO MEET  
11 NUTRITIONAL NEEDS DUE TO SPECIAL DIETARY NEEDS DIRECTLY RELATED  
12 TO CANCER, CHRONIC KIDNEY DISEASE, DIABETES, MALNUTRITION, OR  
13 FAILURE TO THRIVE, AS THOSE TERMS ARE DEFINED BY THE WORLD  
14 HEALTH ORGANIZATION'S "INTERNATIONAL CLASSIFICATION OF  
15 DISEASES" (TENTH REVISION), AS AMENDED OR REVISED, OR ANY OTHER  
16 MEDICAL CONDITIONS AS DETERMINED BY THE COMMISSION BY RULE;  
17 AND".

18 Page 2 of the report, line 35, strike "(XIV)" and substitute "(XV)".

19 Page 12 of the report, strike line 23 and substitute:

20 ""(e) AN AGRICULTURAL EMPLOYER, AS DEFINED IN SECTION  
21 8-3-104 (1), REGARDLESS OF WHERE THE AGRICULTURAL EMPLOYER IS  
22 LOCATED, WITH LESS THAN FIVE MILLION DOLLARS IN REALIZED GROSS  
23 TOTAL REVENUE IN THE STATE FROM CONSUMER SALES OF AGRICULTURAL  
24 PRODUCTS SOLD UNDER THE BRAND NAME OF THE FARMER, EGG  
25 PRODUCER, GROWER, OR INDIVIDUAL GROWER COOPERATIVE;

26 (f) AN INDIVIDUAL BUSINESS OPERATING A RETAIL FOOD".

27 Renumber succeeding paragraph accordingly."
