- 25 EXPENDITURES AND CONSUMER SPENDING ON RECYCLING SERVICES AND
- 26 TRASH COLLECTION AND DISPOSAL.".

- 30 PROVIDER IS NOT REQUIRED TO PROVIDE RECYCLING SERVICES UNDER THE
- 31 PROGRAM OR ANY OTHER PLAN APPROVED BY THE EXECUTIVE DIRECTOR
- 32 PURSUANT TO THIS PART 6.".
