

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB22-087 be amended as follows:

1 Amend corrected printed bill, strike everything below the enacting clause
2 and substitute:

3 **"SECTION 1.** In Colorado Revised Statutes, **add** 22-54-123.7 as
4 follows:

5 **22-54-123.7. Federal medicaid demonstration project -**
6 **participation.** AS SOON AS PRACTICABLE AFTER THE EFFECTIVE DATE OF
7 THIS SECTION, THE DEPARTMENT OF EDUCATION SHALL APPLY TO THE
8 FEDERAL SECRETARY OF AGRICULTURE TO PARTICIPATE IN THE
9 DEMONSTRATION PROJECT OPERATED PURSUANT TO 42 U.S.C. SEC. 1758
10 (b)(15) FOR DIRECT CERTIFICATION FOR CHILDREN RECEIVING MEDICAID
11 BENEFITS, WITH THE INTENT THAT THE DEMONSTRATION PROJECT IS
12 IMPLEMENTED STATEWIDE TO THE EXTENT ALLOWABLE UNDER FEDERAL
13 LAW. IF THE STATE IS SELECTED TO PARTICIPATE IN THE DEMONSTRATION
14 PROJECT, THE DEPARTMENT OF EDUCATION SHALL COMPLY WITH ALL OF
15 THE REQUIREMENTS OF THE DEMONSTRATION PROJECT, INCLUDING
16 ENTERING INTO AN AGREEMENT WITH THE DEPARTMENT OF HEALTH CARE
17 POLICY AND FINANCING TO ESTABLISH PROCEDURES BY WHICH A STUDENT
18 MAY BE CERTIFIED, WITHOUT FURTHER APPLICATION, AS MEETING THE
19 ELIGIBILITY REQUIREMENTS FOR FREE OR REDUCED-PRICE MEALS
20 PURSUANT TO THE FEDERAL SCHOOL BREAKFAST PROGRAM, CREATED IN
21 42 U.S.C. SEC. 1773, AND THE FEDERAL SCHOOL LUNCH PROGRAM,
22 CREATED IN THE "RICHARD B. RUSSELL NATIONAL SCHOOL LUNCH ACT",
23 42 U.S.C. SEC. 1751 ET SEQ., BASED ON INFORMATION COLLECTED BY THE
24 DEPARTMENT OF HEALTH CARE POLICY AND FINANCING IN IMPLEMENTING
25 THE MEDICAID PROGRAM.

26 **SECTION 2.** In Colorado Revised Statutes, **amend** 22-100-105
27 as follows:

28 **22-100-105. Repeal of article.** This article 100 is repealed,
29 effective ~~January 1, 2024~~ JULY 1, 2028.

30 **SECTION 3. Act subject to petition - effective date.** This act
31 takes effect at 12:01 a.m. on the day following the expiration of the
32 ninety-day period after final adjournment of the general assembly; except
33 that, if a referendum petition is filed pursuant to section 1 (3) of article V
34 of the state constitution against this act or an item, section, or part of this
35 act within such period, then the act, item, section, or part will not take
36 effect unless approved by the people at the general election to be held in
37 November 2022 and, in such case, will take effect on the date of the
38 official declaration of the vote thereon by the governor."
