Committee on Local Government & Housing.

SB23-213 be amended as follows:

1 Amend printed bill, page 45, after line 13 insert:

2 **"29-33-114. Municipal election requirement.**

3 (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS PART 1 TO THE  
4 CONTRARY, THE REQUIREMENTS OF THIS PART 1 DO NOT APPLY TO A LOCAL  
5 GOVERNMENT UNLESS:

6 (a) THE LOCAL GOVERNMENT'S GOVERNING BODY SUBMITS A  
7 PROPOSAL TO THE REGISTERED ELECTORS OF THE LOCAL GOVERNMENT  
8 CONCERNING THE APPLICABILITY OF THIS PART 1 IN THE LOCAL  
9 GOVERNMENT, AS PART OF A COORDINATED ELECTION, AS DEFINED IN  
10 SECTION 1-7-116; AND

11 (b) THE MAJORITY OF THE LOCAL GOVERNMENT'S VOTERS WHO

26 PROPOSAL TO THE SUBJECT JURISDICTION'S REGISTERED ELECTORS  
27 CONCERNING THE APPLICABILITY OF THIS PART 4 IN THE SUBJECT  
28 JURISDICTION, AS PART OF A COORDINATED ELECTION, AS DEFINED IN
