  - **44-10-203.** State licensing authority rules. (1) Permissive rule-making. Rules promulgated pursuant to section 44-10-202 (1)(c) may include but need not be limited to the following subjects:
  - (j.3) The documentation necessary to be provided by a person applying for a social equity license and requirements deemed necessary by the state licensing authority to verify the documentation.
  - (2) **Mandatory rule-making.** Rules promulgated pursuant to section 44-10-202 (1)(c) must include but need not be limited to the following subjects:
  - (dd) Requirements for medical marijuana and medical marijuana products delivery as described in section 44-10-501 (11) and section 44-10-505 (5) and retail marijuana and retail marijuana products delivery as described in section 44-10-601 (13), and section 44-10-605 (5), AND SECTION 44-10-613, including:
  - (II) Training requirements for personnel of medical marijuana stores, retail marijuana stores, INDEPENDENT DELIVERERS, medical marijuana transporters, and retail marijuana transporters that hold a medical marijuana or retail marijuana delivery permit who will deliver medical marijuana or medical marijuana products or retail marijuana or retail marijuana products pursuant to this article 10 and requirements that medical marijuana stores, retail marijuana stores, INDEPENDENT DELIVERERS, medical marijuana transporters, and retail marijuana transporters be considered to have a responsible vendor designation pursuant to section 44-10-1201 prior to conducting a delivery;".
