- 15 "(II) (A) FOR INCOME TAX YEARS COMMENCING ON OR AFTER
- 16 January 1, 2024, but before January 1, 2025, any purchaser of
- 17 SMALL FOOD BUSINESS RECOVERY AND RESILIENCE GRANT PROGRAM
- 18 EQUIPMENT IS ALLOWED A CREDIT AGAINST THE TAX IMPOSED BY THIS
- 19 ARTICLE 22 IN AN AMOUNT EQUAL TO EIGHTY-FIVE PERCENT OF THE
