- 4 CASH, EQUITY, INVESTMENTS, OR OTHER ASSETS TO AND FROM RELATED
- 5 PARTIES, INCLUDING BUT NOT LIMITED TO THE HOSPITAL'S PARENT
- 6 ORGANIZATION. THE SUMMARY MUST INCLUDE THE PURPOSE OF THE
- 7 TRANSFERS AND WHETHER THE TRANSFERS WERE MADE WITHIN OR
- 8 OUTSIDE OF COLORADO. A HOSPITAL MAY AGGREGATE THE TRANSFERS
- 9 FOR EACH ENTITY RECEIVING OR MAKING THE TRANSFER.".".
- Page 2, strike lines 1 through 3 and substitute:
- "Page 4, strike lines 23 through 27 and substitute:
- 12 "(E) A HOSPITAL-SPECIFIC STATEMENT OF CASH FLOW WITHIN A
- 13 TIME FRAME SPECIFIED ANNUALLY BY THE STATE DEPARTMENT, BUT NOT
- 14 LESS THAN ONE HUNDRED TWENTY DAYS AFTER THE HOSPITAL'S FISCAL
- 15 YEAR END.".".
- Page 2, strike lines 14 through 23 and substitute:
- 17 ""(IV) (A) A QUARTERLY FINANCIAL REPORT THAT INCLUDES AN
- 18 INCOME STATEMENT AND BALANCE SHEET. IF A HOSPITAL IS OWNED OR
- 19 AFFILIATED WITH A HEALTH SYSTEM THAT IS COMPRISED OF THREE OR
- MORE HOSPITALS OR THAT HAS MORE THAN ONE BILLION DOLLARS IN
- 21 RESERVES, THE HEALTH SYSTEM MAY SUBMIT A CONSOLIDATED
- 22 QUARTERLY FINANCIAL REPORT.
- 23 (B) ANY QUARTERLY FINANCIAL REPORT MADE PUBLICLY
- 24 AVAILABLE MUST CLEARLY STATE THAT THE QUARTERLY FINANCIAL
- 25 REPORT IS UNAUDITED, IF APPLICABLE. THE STATE DEPARTMENT SHALL
- 26 PROVIDE ANY ANALYSIS, REPORT, OR PRESENTATION BASED ON THE
- QUARTERLY FINANCIAL REPORT TO EACH HOSPITAL AT LEAST FIFTEEN
- 28 DAYS PRIOR TO THE PUBLIC RELEASE OF THE ANALYSIS, REPORT, OR
- 29 PRESENTATION.".".
