5 FOLLOWING FIFTEEN VOTING MEMBERS APPOINTED BY THE EXECUTIVE
6 DIRECTOR:

7 **(A) THREE MEMBERS REPRESENTING DIRECT CARE EMPLOYERS,**
8 INCLUDING ONE MEMBER REPRESENTING A DIRECT CARE EMPLOYER THAT
9 SERVES A RURAL AREA OF THE STATE;

10 **(B) ONE MEMBER REPRESENTING AN EMPLOYER ORGANIZATION;**

11 **(C) THREE MEMBERS WHO ARE ACTIVE DIRECT CARE WORKERS,**
12 INCLUDING ONE MEMBER WHO IS AN ACTIVE DIRECT CARE WORKER WHO
13 SERVES A RURAL AREA OF THE STATE;

14 **(D) ONE MEMBER REPRESENTING A WORKER ORGANIZATION;**

15 **(E) FOUR MEMBERS WHO ARE DIRECT CARE CONSUMERS WHO**
16 RECEIVE DIRECT CARE SERVICES FROM DIRECT CARE WORKERS, INCLUDING
17 ONE MEMBER FROM A RURAL AREA OF THE STATE;

18 **(F) TWO MEMBERS REPRESENTING ORGANIZATIONS THAT**
19 REPRESENT INDIVIDUALS WITH DISABILITIES OR OLDER ADULTS; AND

20 **(G) ONE MEMBER WHO IS AN ECONOMIST WITH HEALTH-CARE**
21 EXPERTISE."."

22 Page 2 of the report, strike lines 11 and 12.

23 Amend printed bill, page 6, line 20, after "SECTION," insert "OF THE
24 MEMBER APPOINTED PURSUANT TO SUBSECTION (2)(a)(I)(B) OF THIS
25 SECTION,".

26 Page 6, line 25, after "SECTION," insert "OF THE MEMBER APPOINTED
27 PURSUANT TO SUBSECTION (2)(a)(I)(D) OF THIS SECTION,".

28 Strike "ON" and substitute "AS AN EX OFFICIO, NONVOTING MEMBER OF"
29 on: **Page 6**, lines 2 and 6.

30 Strike "(2)(a)(I)(B)" and substitute "(2)(a)(I)(A)" on: **Page 6**, lines 20 and
31 25.

32 Strike "ONE MEMBER" and substitute "TWO MEMBERS" on: **Page 6**, lines
33 22 and 27.

- 1 Strike "(2)(a)(I)(D)" and substitute "(2)(a)(I)(E)" on: **Page 6**, line 23; and
- 2 **Page 7**, line 1.
