

## SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Winter F.

1 Amend printed bill, page 3, after line 10 insert:

2       "(1.4) NOTHING IN THIS SECTION APPLIES TO THE USE OF  
3 AUTOMATED VEHICLE IDENTIFICATION SYSTEMS FOR THE PURPOSE OF  
4 COLLECTING TOLLS, FEES, OR CIVIL PENALTIES IN ACCORDANCE WITH PART  
5 5 OF ARTICLE 4 OF TITLE 43 AND SECTION 43-4-808."

6 Page 8 of the bill, strike lines 1 through 3 and substitute:

7       "(VIII) FINAL ORDERS MAY BE APPEALED AS TO MATTERS OF LAW  
8 AND FACT TO THE COUNTY COURT IN THE COUNTY WHERE THE ALLEGED  
9 VIOLATION OCCURRED. THE APPEAL SHALL BE A DE NOVO HEARING."

10 Page 15 of the bill, line 6, after "SECTION." add "THE STATE, COUNTY,  
11 CITY AND COUNTY, OR MUNICIPALITY ISSUING THE VIOLATION SHALL  
12 DISCLOSE THE TWENTY-FIVE DOLLAR ADMINISTRATION FEE IN THE FINAL  
13 ORDER OF LIABILITY. FEES COLLECTED PURSUANT TO THIS SECTION SHALL  
14 BE TRANSMITTED TO THE STATE TREASURER, WHO SHALL CREDIT THE  
15 SAME TO THE COLORADO DRIVES VEHICLE SERVICES ACCOUNT CREATED  
16 IN SECTION 42-1-211 (2)."

17 Page 17 of the bill, line 25, strike "TAKE PHOTOGRAPHS" and substitute  
18 "RETAIN DATA".

19 Page 18 of the bill, line 9, before "OR," insert "FOR TRANSFERRING DATA  
20 TO A NEW VENDOR OR OPERATING SYSTEM,".

21 Page 18 of the bill, before line 16, insert:

22       "**SECTION 2. Effective date.** This act takes effect upon passage;  
23 except that sections 42-4-110.5 (2)(a)(V)(G), (3)(a)(I), (3)(a)(II), and  
24 (3)(b), Colorado Revised Statutes, as enacted in section 1 of this act, take  
25 effect June 1, 2024."

26 Renumber succeeding section accordingly.

27 Amend the Transportation and Energy Committee Report, dated April 5,  
28 2023, page 1, line 4, strike "MAY" and substitute "WILL".

29 Page 1 of the report, line 6, strike the third "THE" and substitute "A  
30 TWENTY-FIVE DOLLAR ADMINISTRATION FEE IS ADDED TO ANY UNPAID

- 1 VIOLATION SUBJECT TO THIS SECTION."."
- 2 Page 1 of the report, strike lines 7 and 8.
- 3 Page 1 of the report, line 23, strike "PERMANENT".
- 4 Page 2 of the report, line 6, strike "OR"." and substitute "AND".
- 5 Page 2 of the report, line 9, strike "PAID; OR"." and substitute "PAID."."
- 6 Page 2 of the report, line 16, strike "lines 2 and 20;" and substitute "line
- 7 20;"
