

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB23-1013 be amended as follows:

- 1 Amend the Judiciary Committee Report, dated January 31, 2023, page 1,
- 2 strike lines 7 through 27 and substitute:  
  
3 "(1) BY JULY 1, 2027, THE DEPARTMENT SHALL IMPLEMENT POLICIES AND  
4 PRACTICES THAT CONFORM TO THE MINIMUM STANDARDS PRESCRIBED BY  
5 THE MOST UPDATED RESTRAINT AND SECLUSION STANDARDS OF THE  
6 NATIONAL COMMISSION ON CORRECTIONAL HEALTH CARE. THE  
7 DEPARTMENT SHALL CONTINUOUSLY AMEND ITS PRACTICES AND POLICIES  
8 TO COMPLY, AT A MINIMUM, WITH THE THOSE MINIMUM STANDARDS."

15 Page 8, strike lines 2 through 5.  
  
16 Renumber succeeding subparagraph accordingly.  
  
17 Page 8, line 40, strike "(8)(b)" and substitute "(4)(b)".  
  
18 Page 9, line 3, after the first "THE" strike "FACILITY OR".  
  
19 Page 9, strike lines 5 through 12.  
  
20 Reletter succeeding paragraphs accordingly.  
  
21 Page 9, line 37, strike "(8)" and substitute "(4)".  
  
22 Page 9, line 39, strike "MARCH 1, 2025" and substitute "JANUARY 1,

24 Page 9, line 39, strike the second "MARCH" and substitute "JANUARY".

3 (8)(d) OF THIS SECTION." and substitute "DAYS; AND".
- 4 Page 10, after line 43 insert:  
5 "(XII) AN IMPLEMENTATION PLAN TO CONFORM WITH THE  
6 REQUIREMENTS PURSUANT TO SUBSECTION (1) OF THIS SECTION,  
7 INCLUDING TIME LINES, A SUMMARY OF PROGRESS, AND A COMPLIANCE  
8 REPORT.  
9 (b) BEGINNING IN 2024 AND EACH YEAR THEREAFTER, THE  
10 DEPARTMENT SHALL PRESENT FINDINGS FROM THE REPORT DESCRIBED BY  
11 THIS SECTION TO THE HOUSE OF REPRESENTATIVES AND SENATE JUDICIARY  
12 COMMITTEES, OR ANY SUCCESSOR COMMITTEES, DURING THE HEARINGS  
13 HELD PURSUANT TO THE "SMART ACT", PART 2 OF ARTICLE 7 OF TITLE  
14 2".

- 16 Page 11, line 5, strike "(9)" and substitute "(5)".
- 17 Page 11, strike lines 38 and 39.
- 18 Reletter succeeding paragraphs accordingly.

- 20 Reletter succeeding paragraphs accordingly.
- 21 Strike "FACILITY OR" on: **Page 8**, lines 17, 28 and 29, 34, and 42; and  
22 **Page 9**, lines 20 and 23.
