- 1 Amend the printed bill, page 28, strike lines 21 through 27 and substitute: 2 "12-170-112. Local jurisdiction. (1) EXCEPT FOR A LOCAL JURISDICTION THAT HAS PROHIBITED THE OPERATION OF NATURAL 3 MEDICINE BUSINESSES ISSUED PURSUANT TO ARTICLE 50 OF TITLE 44 IN ITS JURISDICTION, A LOCAL JURISDICTION SHALL NOT PROHIBIT A FACILITATOR 6 FROM PROVIDING NATURAL MEDICINE SERVICES AT PRIVATE RESIDENCES 7 OF PARTICIPANTS PURSUANT TO RULES PROMULGATED BY THE DIRECTOR 8 WITHIN ITS JURISDICTIONAL BOUNDARIES. NOTHING IN THIS ARTICLE 170 9 MUST BE CONSTRUED TO LIMIT A LOCAL JURISDICTION FROM REGULATING 10 THE TIME, PLACE, AND MANNER OF THE OPERATION OF THE HEALING 11 CENTERS LICENSED PURSUANT TO ARTICLE 50 OF TITLE 44 OR RESTRICTING 12 THE PRACTICE OF FACILITATION IN A RESIDENCE AS A FORM OF HOME 13 OCCUPATION.
- 14 (2) A LOCAL JURISDICTION SHALL NOT ADOPT ORDINANCES OR 15 REGULATIONS THAT ARE IN CONFLICT WITH THIS ARTICLE 170, EXCEPT AS 16 EXPRESSLY PROVIDED BY LAW.".
- Page 31, line 7, strike "170." and substitute "170, EXCEPT AS EXPRESSLY PROVIDED BY LAW.".

- 27 EXPRESSLY PROVIDED BY LAW.".
