

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB23-199 be amended as follows:

1 Amend reengrossed bill, page 4, after line 8 insert:

2 "SECTION 4. In Colorado Revised Statutes, 44-10-801, **amend**  
3 (1)(a)(II); and **add** (6) as follows:

4 **44-10-801. Marijuana cash fund - transfer - repeal.** (1) (a) All  
5 money collected by the state licensing authority pursuant to this article 10  
6 must be transmitted to the state treasurer, who shall credit the same to the  
7 marijuana cash fund, which fund is hereby created and referred to in this  
8 section as the "fund". The fund consists of:

9 (II) Any additional general fund money appropriated OR  
10 TRANSFERRED to the fund that is necessary for the operation of the state  
11 licensing authority.

12 (6) (a) ON OR BEFORE SEPTEMBER 15, 2023, THE DEPARTMENT  
13 SHALL REPORT TO THE STATE TREASURER ON THE AMOUNT OF THE FISCAL  
14 YEAR 2022-23 GENERAL FUND REVERSION FOR THE UNUSED GENERAL  
15 FUND APPROPRIATION IN THE DEPARTMENT'S IDS PRINT PRODUCTION LINE  
16 ITEM OF SENATE BILL 23-214, ENACTED IN 2023.

17 (b) THIS SUBSECTION (6) IS REPEALED, EFFECTIVE SEPTEMBER 1,  
18 2024.

19 **SECTION 5.** In Colorado Revised Statutes, 24-75-219, **add** (7)(i)  
20 as follows:

21 **24-75-219. Transfers - transportation - capital construction -**  
22 **definitions - repeal.** (7) In addition to any other transfers required by  
23 this section:

24 (i) (I) ON OCTOBER 1, 2023, OR SHORTLY THEREAFTER, THE STATE  
25 TREASURER SHALL TRANSFER FROM THE GENERAL FUND TO THE  
26 MARIJUANA CASH FUND, CREATED IN SECTION 44-10-801, THE AMOUNT OF  
27 MONEY THAT THE DEPARTMENT OF REVENUE REPORTS TO THE STATE  
28 TREASURER PURSUANT TO SECTION 44-10-801 (6).

29 (II) THIS SUBSECTION (7)(i) IS REPEALED, EFFECTIVE SEPTEMBER  
30 1, 2024."

31 Renumber succeeding section accordingly.

32 Page 4, strike lines 10 through 14 and substitute: "**applicability.** This act  
33 takes effect at 12:01 a.m. on the day following the expiration of the  
34 ninety-day period after final adjournment of the general assembly; except  
35 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
36 of the state constitution against this act or an item, section, or part of this  
37 act within such period, then the act, item, section, or part will not take  
38 effect unless".
