SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

HB23-1242 be amended as follows:

- 1 Amend reengrossed bill, page 9, line 27, strike "**definitions.**" and  
2 substitute "**definitions - review of functions - repeal.**".
- 3 Page 12, line 8, strike "AGENCY" and substitute "AGENCY, OTHER THAN A  
4 COMMISSIONER OF THE COMMISSION,".
- 5 Page 12, line 11, strike "ENVIRONMENT;" and substitute "ENVIRONMENT.  
6 A STAFF PERSON FOR THE COMMISSION MAY BE APPOINTED PURSUANT TO  
7 THIS SUBSECTION (3)(a)(III)(A).".
- 8 Page 12, line 15, before "NONGOVERNMENTAL" insert "ENVIRONMENTAL".
- 9 Page 13, line 6, strike "NONPROFIT" and substitute "NONGOVERNMENTAL".
- 10 Page 13, line 11, after "EACH" insert "OF WHOM MUST BE", and strike  
11 "NONPROFIT" and substitute "NONGOVERNMENTAL".
- 12 Page 13, line 13, strike "COLOR," and substitute "COLOR OR MUST RESIDE  
13 IN A DISPROPORTIONATELY IMPACTED COMMUNITY,".
- 14 Page 15, line 24, after "WATER;" add "EXCEPT THAT THE CONSORTIUM  
15 SHALL NOT PARTICIPATE AS A PARTY IN ANY RULE-MAKING PROCEEDING;".
- 16 Page 17, after line 20 insert:  
17       "(7) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2030.  
18 BEFORE THE REPEAL, THIS SECTION IS SCHEDULED FOR REVIEW IN  
19 ACCORDANCE WITH SECTION 24-34-104.  
20       **SECTION 3.** In Colorado Revised Statutes, 24-34-104, **add**  
21 (31)(a)(VIII) as follows:  
22       **24-34-104. General assembly review of regulatory agencies**  
23 **and functions for repeal, continuation, or reestablishment - legislative**  
24 **declaration - repeal.** (31) (a) The following agencies, functions, or both,  
25 are scheduled for repeal on September 1, 2030:  
26       (VIII) THE COLORADO PRODUCED WATER CONSORTIUM CREATED  
27 IN SECTION 34-60-135 (2)(a).".
- 28 Renumber succeeding sections accordingly.
