- 14 AUTHORITY SHALL CEASE LICENSING ANY NATURAL MEDICINE BUSINESSES
- 15 OR PREMISES IN THE JURISDICTION.".

- 18 CONSIDERING THE AUTHORITY OF LOCAL JURISDICTIONS TO ENACT

- 20 MANNER OF OPERATIONS OF SUCH PREMISES;".
- 21 Page 51, line 22, strike "PREMISES;" and substitute "PREMISES,
- 22 CONSIDERING THE AUTHORITY OF LOCAL JURISDICTIONS TO ENACT
- 23 ORDINANCES OR REGULATIONS GOVERNING THE TIME, PLACE, AND
- 24 MANNER OF OPERATIONS OF SUCH PREMISES;".
- 25 Page 59, after line 6, add:
- 26 "(e) If the applicant's local jurisdiction has prohibited the
- 27 ESTABLISHMENT AND OPERATION OF NATURAL MEDICINE BUSINESSES.".
- Page 75, line 24, strike "RESOLUTION." and substitute "RESOLUTION;
- 29 EXCEPT THAT A COUNTY, MUNICIPALITY, OR CITY AND COUNTY MAY
- 30 PROHIBIT THE CULTIVATION AND MANUFACTURE OF NATURAL MEDICINE
- 31 OR NATURAL MEDICINE PRODUCT FOR PERSONAL USE BY AN ORDINANCE
- 32 ENACTED BY THE GOVERNING BODY OF THE COUNTY, MUNICIPALITY, OR
- 33 CITY AND COUNTY OR THROUGH THE ENACTMENT OF AN INITIATED OR
- 34 REFERRED MEASURE.".
- Page 78, line 5, strike "SECTION." and substitute "SECTION; EXCEPT THAT
- 36 A COUNTY, MUNICIPALITY, OR CITY AND COUNTY MAY PROHIBIT THE
- 37 CULTIVATION AND MANUFACTURE OF NATURAL MEDICINE OR NATURAL
- 38 MEDICINE PRODUCT FOR PERSONAL USE BY AN ORDINANCE ENACTED BY
- 39 THE GOVERNING BODY OF THE COUNTY, MUNICIPALITY, OR CITY AND
- 40 COUNTY OR THROUGH THE ENACTMENT OF AN INITIATED OR REFERRED
- 41 MEASURE.".
