Amend the Energy and Environment Committee Report, dated April 20, 1 2 2023, page 2, strike line 31 and substitute "CLASS VI PRIMACY. (C) As used in this subsection (9)(c)(III), "cumulative 3 4 IMPACTS" MEANS THE EFFECT ON PUBLIC HEALTH AND THE ENVIRONMENT, 5 INCLUDING THE EFFECT ON AIR QUALITY, WATER QUALITY, THE CLIMATE, 6 NOISE, ODOR, WILDLIFE, AND BIOLOGICAL RESOURCES, CAUSED BY THE 7 INCREMENTAL IMPACT THAT A PROPOSED NEW OR MODIFIED CLASS VI 8 INJECTION WELL WOULD HAVE WHEN ADDED TO THE IMPACTS FROM OTHER 9 PAST, PRESENT, AND REASONABLY FORESEEABLE FUTURE DEVELOPMENT 10 OF ANY TYPE ON THE AFFECTED AREA, INCLUDING AN AIRSHED OR 11 WATERSHED, OR ON A DISPROPORTIONATELY IMPACTED COMMUNITY.".". 12 Page 3, strike lines 27 through 37 and substitute: 13 "Page 15 of the reengrossed bill, after line 22 insert: "(I) "CLASS VI INJECTION WELL IMPACTS" MEANS THE EFFECT ON 14 15 THE PUBLIC HEALTH AND THE ENVIRONMENT, INCLUDING AIR, WATER AND 16 SOIL, AND THE CLIMATE, CAUSED BY THE INCREMENTAL IMPACT THAT A 17 PROPOSED NEW OR SIGNIFICANTLY MODIFIED CLASS VI INJECTION WELL 18 AND ASSOCIATED INFRASTRUCTURE WOULD HAVE WHEN ADDED TO THE 19 IMPACTS FROM OTHER DEVELOPMENT IN THE AFFECTED AREA.".".

- 20 Page 4 of the report, strike lines 2 through 22 and substitute:
- 21 ""(9.3) (a) THE COMMISSION, IN CONSULTATION WITH THE
 22 DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT, MAY ADOPT RULES
 23 TO ESTABLISH A PROCESS TO CERTIFY THE QUANTITY AND DEMONSTRATED
 24 SECURITY OF CARBON DIOXIDE STORED IN A CLASS VI INJECTION WELL.
 - (b) THE COMMISSION, IN CONSULTATION WITH THE DEPARTMENT".
