

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB23-076 be amended as follows:

1 Amend reengrossed bill, page 2, after line 1 insert:

2 "SECTION 1. In Colorado Revised Statutes, 2-2-1304, **amend**  
3 (4)(a) and (6)(b) as follows:

4 **2-2-1304. Duties - meetings - community outreach -**  
5 **designation of organization to accept donations - authority to**  
6 **contract.**

7 (4) (a) On or before September 1, 2013, and every third  
8 September 1 thereafter THROUGH SEPTEMBER 1, 2019, the council shall,  
9 in conjunction with the director of the legislative council, use a request  
10 for proposal process to contract with and designate one or more nonprofit  
11 organizations to provide staffing and operational assistance and to serve  
12 as the custodian of ~~moneys~~ MONEY donated to the council through the  
13 designated organization. THE CONTRACTOR SELECTED FOLLOWING THE  
14 2019 REQUEST FOR PROPOSAL PROCESS SHALL, PURSUANT TO ONE OR  
15 MORE CONTRACTS, PROVIDE SUCH STAFFING, OPERATIONAL, AND  
16 CUSTODIAN SERVICES THROUGH JUNE 30, 2023. THEREAFTER, THE  
17 COUNCIL SHALL, IN CONJUNCTION WITH THE DIRECTOR OF THE  
18 LEGISLATIVE COUNCIL, ON OR BEFORE APRIL 30, 2023, AND, EXCEPT AS  
19 OTHERWISE PROVIDED IN THIS SUBSECTION (4)(a), ON OR BEFORE EVERY  
20 SECOND APRIL 15 THEREAFTER, USE A REQUEST FOR PROPOSAL PROCESS  
21 TO CONTRACT WITH AND DESIGNATE ONE OR MORE NONPROFIT  
22 ORGANIZATIONS TO PROVIDE SUCH STAFFING, OPERATIONAL, AND  
23 CUSTODIAN SERVICES. THE TERM OF EACH CONTRACT ENTERED INTO FOR  
24 A TERM COMMENCING ON OR AFTER JULY 1, 2023, IS TWO STATE FISCAL  
25 YEARS; EXCEPT THAT ANY SUCH CONTRACT MAY BE EXTENDED FOR ONE  
26 ADDITIONAL TWO-YEAR TERM. IF A CONTRACT IS EXTENDED, THE REQUEST  
27 FOR PROPOSAL FOR THE NEXT CONTRACT MUST BE ISSUED ON OR BEFORE  
28 THE APRIL 15 IMMEDIATELY PRECEDING THE EXPIRATION OF THE  
29 EXTENSION TERM. The designated organization shall not be the custodian  
30 of any ~~moneys~~ MONEY appropriated by the state and credited to the fund  
31 created in section 2-2-1306. The designated organization is authorized to  
32 expend any ~~moneys~~ MONEY it receives as is necessary for the operation  
33 of the council and may solicit and accept monetary and in-kind gifts,  
34 grants, and donations used to further the council's duties and  
35 responsibilities. Any ~~such moneys~~ MONEY donated or awarded to the  
36 designated organization for the benefit of the council ~~are~~ IS not subject to  
37 appropriation by the general assembly. Any ~~such moneys~~ MONEY obtained  
38 by the council or the designated organization and not in the fund that ~~are~~  
39 IS unexpended and unencumbered at the time the council is dissolved  
40 shall be distributed according to appropriate federal and state laws

1 governing nonprofit organizations. If a different nonprofit or private  
2 organization is subsequently designated as the custodian of donated  
3 ~~moneys~~ MONEY in accordance with this paragraph (a), any ~~moneys~~ MONEY  
4 that ~~are~~ IS unexpended and unencumbered at the time of the change in  
5 designation shall be promptly transferred by the previously designated  
6 organization to the newly designated organization.

7 (6) (b) On or before ~~April 30, 2021~~, APRIL 20, 2023, and on or  
8 before ~~April 30~~ APRIL 1 of each year thereafter, the council shall select  
9 five members to serve as nonvoting members of the review committee  
10 during the subsequent legislative interim.

11 **SECTION 2.** In Colorado Revised Statutes, 2-2-1305.5, **amend**  
12 (3)(b) and (4) as follows:

13 **2-2-1305.5. Colorado youth advisory council review committee**  
14 **- created.** (3) (b) On or before ~~April 30, 2021~~, APRIL 20, 2023, and on or  
15 before ~~April 30~~ APRIL 1 of each year thereafter, the chair of the legislative  
16 council shall appoint the member serving pursuant to subsection (2)(a)(II)  
17 of this section to serve during the subsequent legislative interim.

18 (4) In odd-numbered years, the speaker of the house of  
19 representatives shall appoint the chair of the review committee and the  
20 president of the senate shall appoint the vice-chair. In even-numbered  
21 years, the president of the senate shall appoint the chair and the speaker  
22 of the house of representatives shall appoint the vice-chair. The  
23 appointing authorities shall make the appointments on or before ~~April 30~~  
24 APRIL 20, 2023, AND ON OR BEFORE APRIL 1 of each year THEREAFTER.".

25 Renumber succeeding sections accordingly.

26 Page 2, strike lines 24 through 26.

27 Page 3, strike lines 1 through 6 and substitute:

28 **"SECTION 6. Safety clause.** The general assembly hereby finds,  
29 determines, and declares that this act is necessary for the immediate  
30 preservation of the public peace, health, or safety.".
