1 Amend reengrossed bill, page 14, strike lines 18 through 22 and
2 substitute:

3 "(b) (I) "LOCAL GOVERNMENT" MEANS EITHER A GOVERNMENTAL
4 ENTITY AUTHORIZED BY LAW TO IMPOSE AD VALOREM TAXES ON TAXABLE
5 PROPERTY LOCATED WITHIN ITS TERRITORIAL LIMITS OR A SEPARATE
6 LEGAL ENTITY CREATED PURSUANT TO SECTION 29-1-203.5 WHOSE
7 BUDGET IS COMPRISED AT LEAST IN PART OF PLEDGED AD VALOREM TAX
8 REVENUE FROM THE GOVERNMENTS THAT CONTRACT TO FORM THE
9 SEPARATE LEGAL ENTITY AND ACCEPTED BY THOSE GOVERNMENTS.
10 (II) "LOCAL GOVERNMENT" DOES NOT MEAN A SCHOOL DISTRICT
11 OR ANY COUNTY, CITY AND COUNTY, CITY, OR TOWN THAT HAS ADOPTED
12 A HOME RULE CHARTER."
