## SB23-287 be amended as follows:

- 1 Amend proposed committee amendment (SB287 L.005), page 1, line 4,
- 2 strike "portion, and (5)(g)(IV);" and substitute "portion, (5)(g)(IV), and
- 3 (5)(g)(V);".
- 4 Page 1, line 5, strike "and (5)(g)(II.7)" and substitute "(5)(g)(II.7), and
- 5 (5)(g)(VIII)".
- Page 1, after line 5 insert "Page 5, line 9, strike "- definitions." and 6
- 7 substitute "- definitions - repeal.".".
- 8 Page 1, strike line 38 and substitute:
- 9 "funds to eligible districts as specified in section 22-54-107 (4).
- 10 (V) For the 2010-11 budget year and each budget year thereafter
- THROUGH THE 2023-24 BUDGET YEAR, if a district levies the number of 11
- 12 mills calculated pursuant to section 22-54-106 (2)(a)(I), (2.1)(b)(I)(A),
- 13 (2.1)(b)(I)(B), or (2.1)(b)(II), or (2.1)(c)(II), (2.1)(c)(III), or (2.1)(c)(IV),
- 14 whichever is applicable, and the district's reduction amount exceeds the
- 15 district's state share of total program funding, such district's total program
- 16 funding is the amount calculated pursuant to subsection (2) of this section
- 17 for the applicable budget year, minus the district's state aid. Any such
- 18 district shall use the revenues generated by the number of mills that the
- 19 district levies pursuant to section 22-54-106 (2)(a)(I), (2.1)(b)(I)(A),
- 20 (2.1)(b)(I)(B), or (2.1)(b)(II), or (2.1)(c)(II), (2.1)(c)(III), or (2.1)(c)(IV),
- 21 whichever is applicable, to replace any categorical program support funds
- 22 that the district would otherwise be eligible to receive from the state;
- 23 except that the amount of categorical program support funds that the
- 24 district is required to replace must not exceed an amount equal to the
- remainder of the district's reduction amount after the reduction to the 25 26 district's total program has been applied pursuant to this subsection
- 27 (5)(g)(V). The department of education shall use the amount of
- 28 categorical program support funds replaced by property tax revenue
- pursuant to this subsection (5)(g)(V) to make payments of categorical 29
- 30 program support funds to eligible districts as specified in section
- 31 22-54-107 (4).
- 32 (VIII) This subsection (5)(g) is repealed, effective July 1,
- 2024.". 33
