- 23 THE PROPERTY TAX YEAR COMMENCING ON JANUARY 1, 2023, THEN THE
- 24 LOCAL GOVERNMENTAL ENTITY'S TOTAL PROPERTY TAX REVENUE
- 25 REDUCTION IS BASED ONLY ON THE TEMPORARY REDUCTIONS IN
- VALUATION FOR ASSESSMENT MADE IN SENATE BILL 22-238, ENACTED IN
- 27 2022.".
