

## SENATE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 11, after line 2 insert:

2       "(e) FOLLOWING THE HEARING CONDUCTED PURSUANT TO  
3 SUBSECTION (7)(b) OF THIS SECTION, THE COURT MAY ORDER A STAY OF  
4 EXECUTION OF THE SENTENCE FOR ANY PERIOD OF TIME THROUGH THE END  
5 OF THE PREGNANCY OR THE POSTPARTUM PERIOD. THE COURT SHALL  
6 ORDER A DATE, TIME, AND PLACE FOR THE DEFENDANT TO APPEAR TO  
7 SERVE THE SENTENCE UPON COMPLETION OF THE STAY OF EXECUTION.

8       (f) IF THE COURT GRANTS A STAY OF EXECUTION PURSUANT TO  
9 SUBSECTION (7)(e) OF THIS SECTION, THE COURT SHALL ORDER THE BOND  
10 AND THE CONDITIONS OF THE BOND TO REMAIN IN EFFECT UNTIL THE DATE  
11 THE PREGNANT OR POSTPARTUM DEFENDANT IS ORDERED TO START  
12 SERVING THE DEFENDANT'S SENTENCE."

13 Reletter succeeding paragraphs accordingly.

14 Page 22, after line 7 insert:

15       "(e) FOLLOWING THE HEARING CONDUCTED PURSUANT TO  
16 SUBSECTION (7)(b) OF THIS SECTION, THE COURT MAY ORDER A STAY OF  
17 EXECUTION OF THE SENTENCE FOR ANY PERIOD OF TIME THROUGH THE END  
18 OF THE PREGNANCY OR THE POSTPARTUM PERIOD. THE COURT SHALL  
19 ORDER A DATE, TIME, AND PLACE FOR THE JUVENILE TO APPEAR TO SERVE  
20 THE SENTENCE UPON COMPLETION OF THE STAY OF EXECUTION.

21       (f) IF THE COURT GRANTS A STAY OF EXECUTION PURSUANT TO  
22 SUBSECTION (7)(e) OF THIS SECTION, THE COURT SHALL ORDER THE BOND  
23 AND THE CONDITIONS OF THE BOND TO REMAIN IN EFFECT UNTIL THE DATE  
24 THE PREGNANT OR POSTPARTUM JUVENILE IS ORDERED TO START SERVING  
25 THE JUVENILE'S SENTENCE."

26 Reletter succeeding paragraphs accordingly.
