- 4 Page 5, line 22, strike "STATE;" and substitute "STATE AND AT LEAST ONE
- 5 MEMBER WHO HAS BEEN AN ACTIVE DIRECT CARE WORKER IN THE STATE
- 6 FOR AT LEAST FIVE YEARS;".
- 7 Page 5, line 26, strike "DISABILITIES" and substitute "DISABILITIES, AT
- 8 LEAST ONE MEMBER WHO IS A DIRECT CARE CONSUMER WHO HAS BEEN
- 9 RECEIVING DIRECT CARE SERVICES IN THE STATE FOR AT LEAST FIVE
- 10 YEARS,".
- 11 Page 8, after line 3 insert:
- 12 "(9) **Nondisclosure requirement.** At the time of appointment
- 13 TO THE BOARD, EACH MEMBER SHALL SIGN A NONDISCLOSURE AGREEMENT
- 14 THAT PROHIBITS THE MEMBER FROM DISCLOSING ANY PERSONAL
- 15 INFORMATION ABOUT A DIRECT CARE WORKER, DIRECT CARE EMPLOYER,
- 16 OR DIRECT CARE CONSUMER THAT THE MEMBER RECEIVES IN THE COURSE
- 17 OF PERFORMING DUTIES AS A MEMBER OF THE BOARD. A MEMBER WHO
- 18 FAILS TO COMPLY WITH THE NONDISCLOSURE AGREEMENT IS SUBJECT TO
- 19 A CIVIL PENALTY OF ONE THOUSAND DOLLARS FOR EACH VIOLATION.".
