## SENATE FLOOR AMENDMENT

Second Reading

1 Amend the printed bill, after line 12 insert:

2 "SECTION 2. In Colorado Revised Statutes, 16-11.3-102, **amend**  
3 (2)(a) introductory portion, (2)(a)(III), (2)(a)(IV), (2)(a)(XI) introductory  
4 portion, (2)(a)(XI)(F), (2)(a)(XI)(H), (2)(a)(XI)(M), and (6); **repeal**  
5 (2)(a)(XI)(C); and **add** (2)(a)(XI)(H.5) as follows:

6 **16-11.3-102. Colorado commission on criminal and juvenile**  
7 **justice - creation - membership - operation.** (2) (a) The commission  
8 consists of ~~twenty-nine~~ THE FOLLOWING voting members: ~~as follows~~

9 (III) ~~The executive director of the department of human services,~~  
10 ~~or his or her designee~~ THE COMMISSIONER OF THE BEHAVIORAL HEALTH  
11 ADMINISTRATION, OR THE COMMISSIONER'S DESIGNEE;

12 (IV) ~~The executive director of the department of higher education,~~  
13 ~~or his or her designee~~ A REPRESENTATIVE OF HIGHER EDUCATION WITH  
14 EXPERTISE IN THE TOPIC OF CRIMINAL JUSTICE;

15 (XI) ~~Thirteen members~~ MEMBERS appointed by the governor as  
16 follows:

17 (C) ~~An expert in juvenile justice issues;~~

18 (F) ~~A TWO~~ criminal defense ~~attorney~~ ATTORNEYS, AT LEAST ONE  
19 OF WHOM MUST BE AN ATTORNEY IN A RURAL JUDICIAL DISTRICT;

20 (H) One member who is a representative of a ~~community~~  
21 ~~corrections provider, a community corrections board member, or a~~  
22 behavioral, mental health, or substance use disorder treatment provider;

23 (H.5) ONE MEMBER WHO IS A REPRESENTATIVE OF A COMMUNITY  
24 CORRECTIONS PROVIDER OR A COMMUNITY CORRECTIONS BOARD;

25 (M) ~~Two members who shall be appointed at-large~~ ONE MEMBER  
26 WHO WORKS WITH A COMMUNITY-BASED REENTRY PROGRAM.

27 (6) The commission shall meet at least once per month or on a  
28 schedule determined by the chairperson to review information necessary  
29 for making recommendations. THE CHAIRPERSON SHALL MAKE EVERY  
30 EFFORT TO SCHEDULE MEETINGS AT A TIME AND LOCATION, AND IN A  
31 MANNER, THAT MAXIMIZES PARTICIPATION BY ALL INTERESTED PARTIES."
