SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB24-088 be amended as follows:

- 1 Amend printed bill, page 8, strike lines 2 through 20 and substitute:
2 "(XIV) THE AMOUNT WITHHELD BY THE SCHOOL DISTRICT FOR
3 ADMINISTRATIVE SERVICES OR ASSOCIATED COSTS PROVIDED TO A
4 DISTRICT CHARTER SCHOOL, REPORTED AS A PERCENTAGE OF THE SCHOOL
5 DISTRICT'S TOTAL FORMULA PER PUPIL FUNDING;".
- 6 Page 8, strike lines 26 and 27 and substitute "REIMBURSEMENT THAT IS
7 EXPENDED ON SPECIAL".
- 8 Page 9, strike lines 2 through 4 and substitute "CHARTER SCHOOL; AND".
- 9 Page 9, line 5, after "A" insert "HIGH-LEVEL".
- 10 Page 9, strike lines 7 and 8 and substitute "SCHOOL IN EXCHANGE FOR
11 THE".
- 12 Page 9, strike lines 10 through 13.
- 13 Page 9, strike lines 17 and 18 and substitute "CHARTER SCHOOL:".
- 14 Page 9, strike lines 19 through 27 and substitute:
15 "(I) THE TOTAL NUMBER OF DISTRICT CHARTER SCHOOLS THAT
16 OPERATE ON SCHOOL-DISTRICT-OWNED LAND OR IN A
17 SCHOOL-DISTRICT-OWNED FACILITY; AND
18 (II) THE AVERAGE COST PER STUDENT CHARGED BY THE SCHOOL
19 DISTRICT TO THE DISTRICT CHARTER SCHOOLS THAT OPERATE ON
20 SCHOOL-DISTRICT-OWNED PROPERTY OR IN A SCHOOL-DISTRICT-OWNED
21 FACILITY;".
- 22 Page 10, strike lines 1 through 12.
- 23 Page 10, strike lines 18 through 27 and substitute "ASSOCIATED COSTS, TO
24 A DISTRICT CHARTER SCHOOL, THE TOTAL NUMBER OF DISTRICT CHARTER
25 SCHOOLS THAT RECEIVED SERVICES OR ASSOCIATED COSTS, AND THE
26 TOTAL NUMBER THAT DID NOT RECEIVE SERVICES OR ASSOCIATED COSTS;".
- 27 Page 11, strike lines 1 through 4.
