1 Amend printed bill, page 16, after line 7 insert:

2 **"18-12-605. Task force to study public health issues related to**
3 **mass shootings - created - membership - issues for study - report -**
4 **repeal.** (1) THERE IS CREATED A TASK FORCE TO STUDY PUBLIC HEALTH
5 ISSUES RELATED TO MASS SHOOTING INCIDENTS IN COLORADO AND
6 NATIONALLY. THE TASK FORCE SHALL CONVENE ON OR BEFORE AUGUST
7 15, 2024, AND MEET AT LEAST TEN TIMES AT LOCATIONS THROUGHOUT
8 THE STATE, IN NO LESS THAN FIVE SEPARATE COUNTIES, UNTIL AUGUST 15,
9 2025. THE TASK FORCE CONSISTS OF THE FOLLOWING MEMBERS,
10 APPOINTED ON OR BEFORE AUGUST 1, 2024:

11 (a) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES SHALL
12 APPOINT TWO JUVENILE PSYCHOLOGISTS; TWO ADULT PSYCHOLOGISTS;
13 AND TWO MEMBERS OF THE HOUSE OF REPRESENTATIVES;

14 (b) THE MINORITY LEADER OF THE HOUSE OF REPRESENTATIVES
15 SHALL APPOINT TWO MEMBERS WHO ARE DISTRICT ATTORNEYS IN
16 COLORADO; TWO MEMBERS WHO ARE SCHOOL COUNSELORS OR TEACHERS;
17 AND ONE MEMBER OF THE HOUSE OF REPRESENTATIVES;

18 (c) THE PRESIDENT OF THE SENATE SHALL APPOINT TWO MEMBERS
19 FROM THE COLORADO ORGANIZATION FOR VICTIM ASSISTANCE; TWO
20 SHERIFFS FROM RURAL COUNTIES; AND TWO MEMBERS OF THE SENATE;
21 AND

22 (d) THE MINORITY LEADER OF THE SENATE SHALL APPOINT TWO
23 VICTIMS OF A VIOLENT CRIME IN COLORADO WHO OWN A FIREARM; TWO
24 WHO ARE COLLEGE OR HIGH SCHOOL STUDENTS IN COLORADO; AND ONE
25 MEMBER OF THE SENATE.

26 (2) THE PUBLIC HEALTH STUDY MUST STUDY ISSUES THAT MIGHT
27 CONTRIBUTE TO MASS SHOOTINGS, INCLUDING, BUT NOT LIMITED TO,
28 VIOLENT PASTS; USE OF VIDEO GAMES OR VIOLENT MOVIES; PAST
29 MEDICATION USED FOR BEHAVIORAL DISORDERS; STATUS OF FAMILY LIFE;
30 IF INDIVIDUALS OBTAIN FIREARMS USED LEGALLY OR ILLEGALLY; AND
31 WHICH WEAPONS DEFINED IN SECTION 18-12-602 HAVE BEEN USED IN MASS
32 SHOOTINGS IN COLORADO AND NATIONALLY.

33 (3) (a) LEGISLATIVE MEMBERS OF THE TASK FORCE MAY BE
34 COMPENSATED FOR REASONABLE AND ACTUAL EXPENSES PURSUANT TO
35 SECTION 2-2-317.

36 (b) NONLEGISLATIVE MEMBERS OF THE TASK FORCE MAY BE
37 COMPENSATED FOR REASONABLE AND ACTUAL EXPENSES PURSUANT TO
38 SECTION 2-2-307.

39 (4) THE TASK FORCE SHALL REPORT ITS FINDINGS TO THE JOINT
40 HEALTH AND HUMAN SERVICES COMMITTEE NO LATER THAN JANUARY 30,
41 2026.

42 (5) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2026."
