AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Lake Stevens Sewer District from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance – unemployment compensation
- Payroll – evaluated design of controls over wages and salaries, employee benefits, and compensated absences
- General disbursements – credit card activity, travel expenditures, and meals with meetings
- Selected IT security policies, procedures, practices, and controls protecting financial systems, IT systems, and data

INFORMATION ABOUT THE DISTRICT

The Lake Stevens Sewer District was incorporated in 1957. The District provides sewer services to approximately 32,785 customers in the City of Lake Stevens and the surrounding areas in Snohomish County.

An elected, three-member Board of Commissioners governs the District. Commissioners serve staggered, six-year terms. The Board appoints a General Manager to oversee the District's daily operations as well as its 25 employees. For fiscal years 2016 and 2017, the District had operating revenues of \$12,731,317 and \$13,411,491 respectively.
