

A Policy Type Breakdown

BASIC PERILS (HO1 or DP1)

Covers all eligible property for loss caused by:

Fire or Lightning Vehicles Windstorm & Hail

Explosion Smoke Volcanic eruption

Riot or civil commotion Aircraft Vandalism or malicious mischief

Loss Settlement is ACV

BROAD PERILS COVERAGE (HO2 or DP2)

All Forms. DP1 PLUS adds the following additional named perils:

Falling objects Sudden and accidental tearing apart, cracking, burning or bulging

Weight of ice, snow or sleet Sudden and accidental damage from artificially generated overflow of

water or steam

Freezing Sudden and Accidental discharge of electrical current

Loss settlement is replacement cost for Coverage A provided the home is insured to 100% of the replacement cost. Coverage C losses are settled on actual cash value.

SPECIAL COVERAGE (HO3 or DP3)

Covers Dwelling, Other Structures, and Loss of Use against ALL risks of physical loss, with certain exceptions.

Personal Property is covered for the same perils as provided in BROAD PERIL'S COVERAGE HS 00 02.

Loss settlement is replacement cost for Coverage A provided the home is insured to 100% of the replacement cost. Coverage C losses are settled on actual cash value.
