I didn't have my phone with me on Friday February 12, 2016 when he stalked me again, so I figured there must be some sort of tracking device on my car.

I found a tracking unit underneath my car and called the Huntington Beach Police. They took off the tracking device off my car for fingerprinting and advised me to get a restraining order.

My Wife and I had communication in Yorba Linda at school she was going to an interview for. My wife stated she didn't feel safe according to temporary restraining order papers which have been served to me. She stated I tracked her through her Iphone. She also stated that I would leave her alone.

This day me and my wife had communication in Yorba Linda at a school she was having an interview and I mentioned to her that I was very worried about her since I had no way of contacting her and knowing if she was okay or not. She mentioned to me she understood that I had every right to worry about her and she apologized for the leaving in the manner she left on the 23rd of January from our apartment in Torrance. I talked to her at the school for 1 hour and at no time she never made a statement that she didn't feel safe. After the hour my wife mentioned to me that she was hungry and I said I was also hungry she said do you want to get some food? I said yes but do you know of any places we can get some food? She mentioned some food places like going to Surf City Nights in Huntington Beach but she said it would remind her to much of the good times we had with each other there. I told her well we can eat somewhere around Yorba Linda but I said I wouldn't know where to go. She said to follow her car and she would find a place close by. I told her ok, sounds great. I followed her because she wanted me to and then we arrived to some Peruvian restaurant in Yorba Linda named Andes Peruvian Grill address 19715 Yorba Linda Blvd, Yorba Linda Ca. We talked for over 4 hours and she even smiled and joked about certain things and cried and had a heart to heart about our unresolved circumstances we had some delicious food. She also mentioned to me her employment of places she worked at to me. I told her that I wanted to give her some of her stuff because I could not fit most of it in

my car. I told her I would drop her stuff off in three days at her work. I mentioned to her in the conversation and after we left the restaurant my wife mentioned that she was craving ice cream so I said lets get some because I know you love your deserts and she laughed then we went to Oahu Shaved Ice & Ice Cream next door to the Peruvian restaurant. We shared the ice cream and spoon and we talked for another hour. I talked to her for a total of 6 hours if she didn't feel safe she would have mentioned it to me during the 6 hour conversation.

Friday February 12th, 2016

I went to my wife's work to bring her stuff and honestly she was surprised that I came back but I came given the conversation we had on the 9th she had forgotten what we talked about on the 9th regarding getting her stuff from me. My wife stated she didn't have her phone with her but that was not true on the temporary order she stated that but that was not true my wife had her phone with her. She didn't give me much of a chance to talk and in all honesty I felt ambushed and setup when because I came initially because she said she worked at Precision Dance Studio in Anaheim and I did mention I would come on the 12th bring some of her stuff My wife was

aware of the day and time that I was going to come or else I would not know the time she got out form work. She said what are you doing here I said first I came to the prior conversation we had on the 9th of bringing your stuff. She replied ok. I did say this to her in life sometimes things happen for a reason. I

mentioned to her that if for some reason god wills it I could pass away on some accident. I said would you regret not opening your heart if for some reason god took me from this world? She said yes. I mentioned to her resentment has consumed your heart. I told her that the devil is the deceiver and he is one trying to divide our marriage. I said don't you think that it was appropriate for you a Christian in faith to go to Las Vegas and sin and give out your number at some bar to a guy. I said I forgive her for her actions because I know Jesus has forgiven me and if he can forgive I can forgive to. I mentioned the devil can even work through friends and family to deceive and divide our marriage. I stated the only person invested in destroying a marriage its devil himself. At this point she forgot the conversation we had on the 9th about me coming. Her father called her during the conversation and she picked up her phone said dad he is here. She replied to her father that she did not want to call the police because she cares about me and didn't want cause me trouble with the law and she knows I wouldn't hurt her. I told my wife and said as to the prior conversation and I came to drop off your clothes. I then stated that I'm going back home. I said please think about these things with your heart and I left crying. She knew from the 9th that she was aware of the tracker already that's why I didn't remove it because she could have taken it off from our car anytime after the day of the 9th but she made the decision not to take it off until she stated in the report of the 14th of February. 5 days after she had known about the device and then she decided to file an order. Which I don't believe this decision was made by her judgment but her mother's judgment. I left it so she can do what pleases with the device toss or throw it away. Some reason she did not remove it and then I find out it's now being attempted to be used against me. I would never think of my wife as someone who would try to sabotage me in this manner but I do feel this was planned by her mom. I do think her mother is attempting continue to push my wife into pushing her ill heart towards me but I do believe she is being deceived by the evil of this world. I do pray each day for her heart to heal and accept other demographics in society.

Friday February 13th of 2016

My wife stated that two of her family's cars had identical screws driven into the tires. This is something which is a false accusation I had never been any sort of handy man or mechanic or criminal to damage property of someone who I care and love regardless of this accusation I care about her family and mean nothing but happiness to them and not bad intentions I'm saddened that I would be accused of wrong doing when I have done no wrong. If I did wrong I can admit my wrongs and not have to deny it. This is a defamation of who I am as person who has a degree in Criminal Justice and a proud volunteer for the District Attorney's office for the Victim Assistance Program in Los Angeles. I worked hard in my life to have a clean record become stolen from me. I have always been a role model to kids and grownups by participating in my community and being a part of the process. I'm a business outreach director for a local business organization I have a job and I'm currently working on my campaign running for congress in the 43rd congressional district running as Republican. I don't smoke drink or do drugs. I have no criminal background. I take pride in being the person that I am. I have been working on watching my health and eating better. I have lost 20 pounds in one moth according to my doctor and my blood pressure went from 140 to 120. To be honest I don't have time to spend damaging family's property because this not becoming of the man I am. The same goes for having contact with my wife. Since the 12th of February we have not seen each other or had direct contact with each other. I have no reason to reach out as of the day of 12th of February I did everything in good conscience to repair our marriage. It's up to God at this point

and if she opens her heart to reach out on her own merit.

Prior Abuse –

Tried Slamming Car Door at her face – This something which isn't true because I would never harm my wife. I think there would be a police report of damage to her face or attempted actions from that time and prior medical records of this happening. If I was that bad then why did she continue to date me and said yes when I proposed to her and then said yes on our wedding day? I did not shake her arms in the violent manner as she described. I won't deny that I threw cups and plates this was one time 8 months ago once. It was not directed at her because she was in the coach and the kitchen is far from the coach. I was upset over a disagreement but I was calm after. I did apologize and said that I was wrong for doing such thing and I didn't mean for her to take it the wrong way. I did apologize and we made up that day about it. I never threw my wedding ring out the window out of anger. I took my ring off when I was upset because I found her sending naked pictures to guy from her phone on her email at the time and I was very disturbed and upset. I did realize the pictures she sent were sent out within the first day we had been boyfriend and girlfriend. It was not my duty to hold the past against her. I never threatened to kill myself. I love myself and god loves me. I have dreams to have buildings named after me. I value my life way too much. The car door incident happened during the time of the naked pictures I asked her to stop and please pull over and please give me time to walk and clear my mind. My wife has threatened to commit suicide in the past when I was close to leaving her over the issue with pictures. I didn't because I'm a forgiving person. She stated in the past her mother was a contributor to her anxiety and depression. She stated she was controlling and so was her middle sister. She complained so much about her mother and middle sister to our friends in the south bay and my family. She even accused her family of discriminating me racially. Her father stated on Christmas Omar can't relate to Luke and Josh because he's not like them. Torey was upset on the way back from Christmas about her dad's words and her sister hate rhetoric towards a gift she gave her brother in law.
