On Wednesday, November 22, 2017 at about 1241 hours, a marked City of Hollywood police vehicle operated by Hollywood Police Officer Kwesi Alleyne arrived at or about 1747 Van Buren Street and stopped. Probable Cause Affidavit

Before me this date personally appeared MILLARES, BORIS (2459) who being first duly sworn deposes and says that on 26 day of October, (year) 2018 at 1705 VAN BUREN ST, HOLLYWOOD, FL 33020 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Officer Alleyne exited the police vehicle and made contact with several subjects, including Mr. [REDACTED]. The subjects were in possession of narcotics and a machete amongst several other items supposedly to be used during an impromptu video shoot. While Officer Alleyne was speaking with the group, Mr. [REDACTED] decided to flee on foot and began running southbound. Officer Alleyne, who was fully dressed in a visible Hollywood Police Department Uniform, gave chase.

After running south, toward Van Buren Street, Mr. [REDACTED] ran east and then back north toward 1705 Van Buren Street. As they both reached a grassy area, on the west side of the 1705, Mr. [REDACTED] slows down and starts turning his body towards Officer Alleyne. Mr. [REDACTED] postures himself into a fighting stance, with both arms bent at the elbows and his left fist parallel to the ground. As he does this, Officer Alleyne who is still running towards [REDACTED] strikes [REDACTED], in the left face area, with his right hand. [REDACTED] is spun to the right and falls to the ground. While [REDACTED] is on the ground, Officer Alleyne grabs ahold of [REDACTED] right arm/wrist with both arms. Alleyne then releases [REDACTED] left arm and positions his body over [REDACTED], using his right knee as leverage. Using his left arm, Alleyne grabs ahold of [REDACTED] left arm and pulls it behind [REDACTED] back, where he is able to place handcuffs on [REDACTED]. After this, Officer Kwesi Alleyne stands up and, using his left leg, kicks Mr. [REDACTED] head. At that point Officer Alleyne did commit a battery upon the victim herein identified as Mr. [REDACTED]. Officer Kwesi Alleyne did intentionally touch or strike Mr. [REDACTED] against his will, by kicking him, contrary to F.S.S. 784.03(1). Officer Alleyne's kick lifts and turns [REDACTED] head up and to the right. Officer Alleyne then walks away from Mr. [REDACTED] as responding officers arrive on scene.

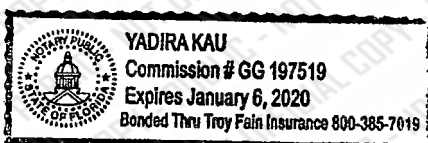

Probable Cause Affidavit

Before me this date personally appeared MILLARES, BORIS (2459) who being first duly sworn deposes and says that on 26 day of October, (year) 2018 at 1705 VAN BUREN ST, HOLLYWOOD, FL 33020 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Officer Alleyne subsequently arrested Mr. [REDACTED] and charged him with Possession of Cocaine, Resist/Obstruct an Officer without Violence and Trespassing where signs are posted. (33-1711-217246) According to the arrest affidavit and incident report Officer Alleyne authored, Alleyne claimed;

"While in pursuit both myself and the defendant [Mr. [REDACTED]] both tripped (without making contact with each other). The defendant struck his face on pavement as a result of tripping. After falling to the ground, I placed 1 hand restraint on the defendant [Mr. [REDACTED]] at which point he began to start pulling away from my grasp and attempting to stand up. I [Officer K. Alleyne] delivered 1 open handed strike to the side of the defendant's [Mr. [REDACTED]] face as a distractionary technique to regain control. As a result of tripping, independent of my [Officer Alleyne] actions, the defendant [Mr. [REDACTED]] sustained a laceration to his nose."

Based on the video evidence, it is clear Officer Alleyne's claims are false. At that point Officer Alleyne did knowingly falsify a document, to wit: a Probable Cause Affidavit and/or Incident/Investigation Report related to Hollywood Police Offense Report number 33-1711-217246, pertaining to the criminal investigation and belonging to any public office within the State, to wit: the Hollywood Police Department, contrary to F.S.S 839.13(1), 775.082 and 778.083.

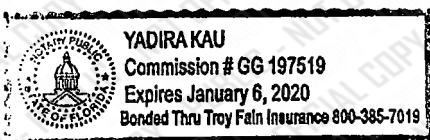
