| On or about May 30, 2019, the Public Integrity Bureau received a complaint |
| involving the arrest of a Mr. Lee Dotson, B/M/28, DOB 8/8/90. |
| On June 3, 2019, the Baltimore Police Body Camera Unit contacted the Public |
| Integrity Bureau related to an audit of the body camera video related to Mr. |
| Dotson's arrest. |
| On June 3, 2019, the Public Integrity Bureau conducted an investigation into the |
| facts and circumstances of the arrest of Mr. Dotson. Investigation revealed that |
| Sergeant Newberg and Officer Alex Young were in the area of the 2300 Block of |
| Ashton Street, with an unknown individual (W/M) who they had stopped for an |
| unrelated matter. |
| While walking past Sergeant Newberg, Mr. Dotson stated, "don't make that man |
| sit on the wet ground," or language to that effect. Sergeant Newberg replied "why |
| don't you mind your business," or language to that effect. Mr. Dotson continued to |
| walk past and away from the officers while continuing to comment that the |
| officers should not have that man sitting on the ground. Sergeant Newberg then |
| ran after Mr. Dotson grabbed him by the forearm with his left hand and with his |
| right hand grabbed the underneath of Mr. Dotson's bicep, placing him under |
| arrest. (cont) |

Mr. Dotson pulled his arm away from Sergeant Newberg, stating, "I'm not running nowhere: Get off me, get off me: I'm suing: it's a freedom of speech you is violating my amendments," or language to that effect. The body worn camera video depicted that Dotson was exercising his first amendment right to free speech, which is legally protected conduct; in fact Dotson did not interfere, but instead kept walking. By running after Dotson and grabbing his arm, Sqt. Newberg's actions caused Dotson to be unlawfully arrested. Sergeant Newberg's actions then caused Officer Young to grab Mr. Dotson and take him to the ground, where Mr. Dotson was subjected to the knee and body weight of an officer and Sergeant Newberg. Mr. Dotson was eventually placed in handcuffs. While in handcuffs Dotson repeatedly stated, "I didn't do anything to you, freedom of speech," or language to that effect. Mr. Dotson asked repeatedly why he was being arrested and Sergeant Newberg stated to Mr. Dotson, to take his charge like a man. Sergeant Newberg then told Mr. Dotson he was being arrested because he didn't know how to act. Mr. Dotson complained of pain and subsequently was transported to St. Agnes Hospital for treatment. The video evidence showed that Sergeant Newberg assaulted Mr. Dotson without his consent and without legal justification. The video evidence also showed that Sergeant Newberg detained Dotson against his will and without legal justification and that he did so by force. Sergeant Newberg unreasonably detained Dotson and arrested him without probable cause. (cont)

APPLICATION FOR STATEMENT OF CHARGES (CONTINUED) Page 4 of 4 After Dotson's arrest, civilians gathered. Sergeant Newberg also was on several occasions belligerent to civilians in the area of arrest of Mr. Dotson, telling them to go to bed and leave the area. Sergeant Newberg also used threatening or profane language at the unidentified individual (W/M), who officers had stopped for an unrelated matter stating, "you want to see nasty, let you come back with that warrant, I'll charge you with disorderly, shut your mouth; you understand me," or language to that effect. It is also depicted on body worn camera that when a Hispanic Officer approached Sergeant Newberg and suggested that he "relax." Sergeant Newberg told the Hispanic Officer to never question the way he does things and ordered him to leave the scene, and later called him, "a kumbaya officer." Based on your writer's preliminary investigation, coupled with the body worn camera video footage, Mr. Dotson resisted an illegal arrest by Sergeant Newberg. During the course of his interaction with Mr. Dotson, Sergeant Newberg was on duty, in uniform, and working in his official capacity, and did corruptly commit an unlawful act by assaulting and detaining Dotson without legal justification.
