FOLLOW UP

ASSIGNMENT/ARRIVAL:

On 01-04-22, I was assigned to District 7, uniform patrol, with the call sign 2b760. At about 1331 hours, I proceeded to 1850 Halekoa Dr. on a pedestrian MVC. I arrived at about 1340 hours.

WITNESS STATEMENT (HUSBAND): Keith MORRILL /M/51

MORRILL was interviewed on the scene and was identified verbally.
MORRILL appeared sober and coherent but distraught.

MORRILL stated that on 01-04-22 his wife, GAELYN Morrill, had his friend's van running and the shifter in drive but GAELYN did not know where the parking brake was. MORRILL then stated that GAELYN was outside of the van when she released the parking brake and the van started to roll onto the street. MORRILL related that GAELYN attempted to get into the vehicle to hit the brake but hit the gas and struck the wall and his vehicle. MORRILL related that GAELYN was thrown into his parked vehicle and became pinned by the van. MORRILL stated that he had to move his vehicle in order to unpin GAELYN.

UNIT 2 DAMAGES:

MORRILL stated that his parked vehicle (TVE975) sustained damages to the passenger side of his vehicle. MORRILL then stated that the damages to the driver's side rear, driver's side front and passenger side front were old damages.

WITNESS STATEMENT (SISTER): Joelle JACKSON /F/51

JACKSON was interviewed on the scene and was identified verbally.
JACKSON appeared to be sober and coherent but very distraught.
Due to JACKSON being distraught, her brother, Lincoln ISHII, wrote JACKSON'S statement.

JACKSON stated that she was behind of the van on the passenger side when she observed the van begin to move forward towards the road. JACKSON then stated that she saw her sister, GAELYN, trying to climb into the van to stop it. JACKSON related that the van rolled down the road and GAELYN slipped and became pinned between the van and MORRILL's vehicle.
